I refer to your application received by ACT Health on 5 July 2018 in which you sought access to information under the *Freedom of Information Act 2016* (the Act).

In your application you have requested:

"...documents related to a meeting between Minister for Health and the former Director-General of Health on 16 March 2018".

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

ACT Health is required to provide a decision on your access application by 2 August 2018.

Decision on access

I can advise that two documents have been identified by ACT Health within the scope of your request. I have decided that these documents will be released in full.

Charges

Processing charges are not applicable for this request in accordance with the Act.

Online publishing – disclosure log

Under section 28 of the Act, ACT Health maintains an online record of access applications called a disclosure log. Your original access application and my decision will be published in the disclosure log not less than three days but not more than 10 days after date of decision. Your personal contact details will not be published.

Ombudsman review

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act. ACT Civil and Administrative Tribunal (ACAT) review


Under section 84 of the Act, if a decision is made under section 82(1) on an Ombudsman review, you may apply to the ACAT for review of the Ombudsman decision.
