Duncan oversaw the successful delivery of the City to Gungahlin light rail project, the ACT Government's largest infrastructure project to date. The Chief Engineer will also play a key leadership role in the new body.

A. The precise details of the Major Projects Canberra budget are being finalised, but its budget will be drawn from existing funding within the ACT public service. 



Transport Canberra and City Services (TCCS) delivers a wide range of services which Canberrans rely on every day. These include collecting recycling and rubbish removal, running public libraries, mowing open space, building and managing our roads, footpaths and cycle paths, operating our public transport system, and maintaining many of Canberra's lakes and ponds. A number of the ACT Government's commercial operations are run by TCCS, including ACT NOWaste, Capital Linen Service, Yarralumla Nursery, and the ACT Public Cemeteries Authority. TCCS employs close to 2000 staff working in locations across the ACT.

Transport Canberra is a significant group within TCCS. Transport Canberra operates the ACTION bus network, manages the delivery of the first stage of light rail in Canberra (from the City to Gungahlin), and is responsible for planning Canberra's second stage of light rail (from the City to Woden).

Overview of the Role

The role of Deputy Project Director Light Rail is a key role within Transport Canberra and City Services, responsible for supporting the Project Director in overseeing the delivery of Stage 1 of the Canberra light rail network. The role may also provide input to the Project Director in technical, engineering, planning, and cost estimation elements of the planning and procurement of Stage 2 of the Canberra light rail network.

1. How many people will work for Major Projects Canberra?

There will be approximately 140 staff in this new body, but numbers will likely change as the SPIRE and LRS2 teams ramp up for delivery.

2. Who will lead the team?

It will be an expert infrastructure delivery team led by a Chief Projects Officer and reporting to the Head of Service and relevant Ministers. The Deputy Director-General of Transport Canberra, Duncan Edghill, will act in the Chief Projects Officer role while longer term recruitment for this role is undertaken. The Chief Engineer will also play a key leadership role in the new body.

3. What is MPC's annual budget (Please specify, even if it is drawn from CM directorate's budget)

The precise details of the Major Projects Canberra budget are being finalised, but its budget will be drawn from existing funding within the ACT public service.

It is likely there will be a series of roles advertised as some staff move between positions.

An EOI will be conducted to fill the existing Deputy Director-General, Transport Canberra role while Mr Edghill is acting in the Chief Projects Officer role.

A number of other Australian jurisdictions have similar delivery bodies for major infrastructure.

This new major projects team will lead the planning, procurement and delivery of some of the territory's largest ever infrastructure projects: Light Rail Stage 2, the Surgical Procedures, Interventional Radiology and Emergency (SPIRE) Centre at the Canberra Hospital, and a new purpose-built campus for CIT that is currently being considered for the Woden Town Centre.

If you are proposed to move into Major Projects Canberra, either Shaun Strachan (IFCW), Cherie Hughes (TCCS) or Liz Lopa (Health) will speak with you prior to 1 July.
- Job Advertisements: If you are informed that your position will move into Major Projects Canberra, it will not be necessary for you to reapply for your role. Your role will continue. However, as both SPIRE and City to Woden Light Rail ramp-up and with the establishment of some corporate roles, it will be necessary to advertise a number of positions (either as Expressions of Interest or permanently). You may see positions being advertised in the near future.
- Accommodation: As noted on Thursday, the current plan is for Major Projects Canberra to be based
 out of the Callam offices in Woden (while other areas of the ACTPS may move into the Belconnen
 space). We will provide further details as soon as we can about when moves may occur. As a
 number of pods in the Callam offices will need to be fit out, not all staff will move on 1 July. We will
 keep you posted once arrangements are finalised.
- Organisation Structure: The organisation structure for Major Projects Canberra is being developed.
 I'll provide further information on this shortly, but I expect we will have areas that reflect the current IFCW team, a central support team, communications and engagement, and the SPIRE and Light Rail teams.

We will keep you informed about transition progress ahead of 1 July. In the meantime, if you have any questions please speak with Shaun, Cherie or Liz as relevant in the first instance. Alternatively, please also feel free to reach out to me.

Colleagues,

The Chief Minister has announced a new collaboration and coordination initiative within the ACT Public Service, with Major Projects Canberra set to commence work on 1 July 2019.

This new major projects team will lead the planning, procurement and delivery of some of the territory's largest ever infrastructure projects: Light Rail Stage 2, the Surgical Procedures, Interventional Radiology and Emergency (SPIRE) Centre at the Canberra Hospital, and a new purpose-built campus for CIT that is currently being considered for the Woden Town Centre.

The new team will be led by a Chief Projects Officer, reporting to me as the Head of Service. Duncan Edghill, TCCS Deputy Director-General, will act in the Chief Projects Officer role while permanent recruitment is undertaken.

Major Projects Canberra will comprise approximately 140 staff, drawing together the expertise of our project delivery teams in Transport Canberra and City Services, the Health Directorate and Infrastructure, Finance and Capital Works in Treasury. Strategic infrastructure policy advice and the ACT Infrastructure Plan will continue to be delivered by Treasury. Major Projects Canberra will be established as a new administrative unit, listed under the Administrative Arrangements.

It is important to acknowledge that changes to existing structures can be unsettling for staff. I want to assure all our colleagues that no staff will be lost in shifting infrastructure delivery responsibilities to Major Projects Canberra.

A transition team, led by Duncan Edghill as the Chief Projects Officer, is being assembled to consult with staff, develop administrative arrangements and undertake other necessary work to establish this new team. The transition team comprises of Cherie Hughes representing TCCS, Shaun Strachan representing CMTEDD and Liz Lopa for the Health Directorate.

Alongside their existing Directors-General, I have met with each of the teams that will be moving into Major Projects Canberra. I also encourage staff to email their transition team contact with suggestions, questions and concerns. Please remember our Employee Assistance Program is available to provide additional assistance and support.

Flexibility in our organisational structure enables us to serve our community in the most efficient and effective ways possible. Major Projects Canberra will make the most of the talent and hard work put in by our infrastructure delivery teams as we make important changes to meet the needs of our growing community.
