DECISION ON YOUR ACCESS APPLICATION

I refer to your application under section 30 of the *Freedom of Information Act 2016* (FOI Act), received by Canberra Health Service on **Tuesday 12 September 2023.**

This application requested access to:

I seek information held by Canberra Health Services in relation to the Dhulwa Mental Health Unit:

From 01/07/2022 to 12/09/2023

- 1. Any correspondence between Canberra Health Services officials regarding concerns about or requests for searches for illicit substances at Dhulwa by staff or police.
- 2. Information (numbers of) and correspondence regarding consumers who have failed to return to the Dhulwa from leave and measures taken to find or return them to the facility.
- 3. Information (numbers of) and correspondence regarding reportable incidents (violence or damage to property) involving consumers at Dhulwa believed to have been under the influence of illicit substances or alcohol on return from leave.

I am an Information Officer appointed by the Chief Executive Officer of Canberra Health Services (CHS) under section 18 of the FOI Act to deal with access applications made under Part 5 of the Act. CHS was required to provide a decision on your access application by **Wednesday 25 October 2023**.

I have identified six documents holding the information within scope of your access application. These are outlined in the schedule of documents included at <u>Attachment A</u> to this decision letter.

Decisions

I have decided to grant partial access to all six documents.

My access decisions are detailed further in the following statement of reasons and the documents released to you are provided as <u>Attachment B</u> to this letter.

In reaching my access decision, I have taken the following into account:

- The FOI Act;
- The contents of the documents that fall within the scope of your request;
- The views of relevant third parties; and
- The Human Rights Act 2004

Partial Access

I have decided to grant partial access to six documents at references 1-6 as they contain information that I consider, on balance, to be contrary to the public interest to disclose under the test set out in Section 17 of the FOI Act.

Public Interest Factors Favouring Disclosure

The following factors were considered relevant in favour of the disclosure of the documents:

- Schedule 2, 2.1(a)(i) promote open discussion of public affairs and enhance the government's accountability;
- Schedule 2, 2.1(a)(ii) contribute to positive and informed debate on important issues or matters of public interest;
- Schedule 2, 2.1(a)(iv) ensure effective oversight of expenditure of public funds; and
- Schedule 2, 2.1(a)(viii) reveal the reason for a government decision and any background or contextual information that informed the decision.

Public Interest Factors Favouring Non-Disclosure

The following factors were considered relevant in favour of the non-disclosure of the documents:

• Schedule 2, 2.2 (a)(ii) prejudice the protection of an individual's right to privacy or any other right under the Human Rights Act 2004;

The six documents all have redactions to personal information such as mobile numbers of ACT Government employees and mobile numbers, email addresses and names of non-ACT Government employees that has not been disclosed as this could reasonably be expected to prejudice the protection of the individual's right to privacy.

Charges

Processing charges are not applicable to this request.

Disclosure Log

Section 4 - Contravention of leave

4.1 Unauthorised leave, escape and absconding

If a consumer takes unauthorised leave, fails to return from leave, or absconds during escorted leave, refer to the MHJHADS Unauthorised leave of Admitted People from MHJHADS Inpatient Units Procedure and Dhulwa Escape and Abscond Procedure.

4.2 Suspension and Revocation of Leave

<u>Suspension</u> of leave refers to the temporary cancellation of leave at the discretion of the NiC for a period of not more than 7 days. Any member of the team can raise an issue of concern with the NiC who will then review the leave provisions. Suspended leave can be reinstated by the MDT. Reasons for suspended leave may include, but are not limited to:

- Attempting to bring low risk contraband into Dhulwa or Gawanggal (e.g. electronic devices, pornography, pharmaceuticals),
- Smoking anywhere at Dhulwa or Gawanggal,
- Failure to return from unescorted leave within three hours of planned return time.

Revocation of leave refers to the cancellation of all leave until a new application for leave is submitted to the Leave Panel by the MDT and the consumer. Leave cannot be reinstated by the MDT. Reasons for revocation of leave may include, but are not limited to:

- Attempting to flee staff escorts,
- · Assaulting staff or others
- Using alcohol or other substances
- Offending
- Self-harming or increase in suicide vulnerability

Any decision to suspend or revoke leave (see definition of terms) must be made on clear clinical grounds, i.e. for the safety of the consumer , staff or the public. The revocation or suspension of leave can never be used as a punitive measure.

Hi all,

Following the recent incident whereby a quantity of drugs were suspected to enter Dhulwa a couple of weeks ago, I have looked into the feasibility of using drug detection dogs to support safety and security within the unit.

- There is no legislated reason why drug detection dogs could not enter Dhulwa
- AFP have dogs that detect multiple items
- AMC have dogs that primarily detect drugs
- There is no MOU between either AMC or AFP to include deployment of drug detection dogs to Dhulwa

- Forensic hospital Sydney have used them once in 2017 provided by a private company. During this search
 multiple positive indications were made by dog across the hospital and in various locations, but nothing was
 found.
- NSW police have no jurisdiction to use dogs in hospitals. The private firms do not have any jurisdiction or any special training for making drug detection claims and making arrests.
- A representative from Elite Security and Protection in ACT advised that narcotic detection canines aren't readily available in the ACT, although they are permitted.
- It is not financially viable for a private company to be engaged on an ad hoc basis, additionally this presents inconsistencies for training the dogs

We have procedures in place to manage searches for prohibited items, escalating in restriction. Addressing this issue would be the best way forward in maintaining a drug free environment at Dhulwa.

Using any form of drug detection equipment or dogs must be very carefully considered from HR and the Industrial Relations point of view in case of positive indication of staff. Currently CHS has no policies which cover this situation.

I think this presents as a no go at this time.

Happy to discuss further if required.

Following the recent incident whereby a quantity of drugs were suspected to enter Dhulwa a couple of weeks ago, I have looked into the feasibility of using drug detection dogs to support safety and security within the unit.

- There is no legislated reason why drug detection dogs could not enter Dhulwa
- AFP have dogs that detect multiple items
- · AMC have dogs that primarily detect drugs
- There is no MOU between either AMC or AFP to include deployment of drug detection dogs to Dhulwa
- Forensic hospital Sydney have used them once in 2017 provided by a private company. During this search
 multiple positive indications were made by dog across the hospital and in various locations, but nothing was
 found.
- NSW police have no jurisdiction to use dogs in hospitals. The private firms do not have any jurisdiction or any special training for making drug detection claims and making arrests.
- A representative from Elite Security and Protection in ACT advised that narcotic detection canines aren't readily available in the ACT, although they are permitted.
- It is not financially viable for a private company to be engaged on an ad hoc basis, additionally this presents inconsistencies for training the dogs

We have procedures in place to manage searches for prohibited items, escalating in restriction. Addressing this issue would be the best way forward in maintaining a drug free environment at Dhulwa.

Using any form of drug detection equipment or dogs must be very carefully considered from HR and the Industrial Relations point of view in case of positive indication of staff. Currently CHS has no policies which cover this situation.

I think this presents as a no go at this time.
