Freedom of Information Request: FOI19/21

I refer to your application received by Canberra Health Services on 11 June 2019 in which you sought access to information under the *Freedom of Information Act 2016* (the Act).

In your application you have requested:

- 1. All documents regarding the executive approval of the 'approved duty statement' for staff specialist neurologist recruitment (Position Number 20538) dated 25/02/2014 specifically in relation to point 2 of the responsibility statement- "Develop and deliver a specific service for patients with multiple sclerosis" and point 1 of the selection Criteria- "Extensive experience in the practice of Neurology, with particular emphasis on the care of patients with multiple sclerosis."
- 2. All correspondence between the ACT Health/TCH executive and human resources area about the preparation and/or approval for the job advertisement specifically for the 'continue (and develop) the MS clinic' component of this advertisement (2014). (See File 1)
- 3. All documents about the approval of funding for multiple sclerosis nurse position and approval from human resources department for RN level 2 classification by (or on behalf of) Ms Marina Buchanan-Grey in 2016. (see File 2)

As I am an Information Officer appointed by the CEO of Canberra Health Services under section 18 of the Act to deal with access applications made under Part 5 of the Act. Canberra Health Services provided a decision on your access application by 30 July 2019 as was required. This is an updated decision letter to rectify an error in the original letter regarding the publication of this information on the ACT Health Disclosure log.

Decision on access

Searches were completed for relevant documents and 14 documents were identified that fall within the scope of your request.

I have included as <u>Attachment A</u> to this decision the schedule of relevant documents. This provides a description of each document that falls within the scope of your request and the access decision for each of those documents.

I have decided to grant access in full 8 documents relevant to your request. I have decided to grant access, under section 50 of the Act, to a copy of 6 documents with deletions applied to information that I consider, on balance, to be contrary to the public interest to disclose under the test set out in section 17 of the Act.

My access decisions are detailed further in the following statement of reasons and the documents released to you are provided as <u>Attachment B</u> to this letter.

In reaching my access decision, I have taken the following into account:

- The FOI Act;
- The contents of the documents that fall within the scope of your request;
- The views of relevant third parties; and
- The Human Rights Act 2004.

Documents 1, 6, and 8 - 11 of the identified documents contain information that I consider, on balance, to be contrary to the public interest to disclose under the test set out in section 17 of the Act as the information contained in these folios is personal information about individuals.

Public Interest Factors Favouring Disclosure

I have identified that there are no factors favouring disclosure of this information under Schedule 2, section 2.1.

Public Interest Factors Favouring Non-Disclosure

The following factors were considered relevant in favour of the non-disclosure of the documents:

 Schedule 2.2(a)(ii) - prejudice the protection of an individual's right to privacy or any other right under the Human Rights ACT 2004.

On balance, the information identified is contrary to the public interest and I have decided not to disclose this information.

Charges

Processing charges are not applicable to this request.

Online publishing – disclosure log

Under section 28 of the Act, ACT Health maintains an online record of access applications called a disclosure log. Your original access application, my decision and documents released to you in response to your access application will be published in the ACT Health disclosure log not less than three days but not more than 10 days after the date of this decision. Dear Marina and Rosemary,

As you know, we are still having difficulty finding the funding for an MS nurse from ACT Health.

The pharmaceutical companies are still keen to help if they can. Medicines Australia now prohibits pharmaceutical companies from directly funding a person or a position for pure clinical work, but it is possible to obtain funding for education or research which seems to be the way to go. I would envisage advertising this as a temporary contract for a year with renewal every year if the companies agree to continue to pay. [We can continue to apply to ACT health for funding as well, of course, and this might allow us to make the position permanent.]

I would like to write to five pharmaceutical companies asking each of them to sponsor 1/4 of a position (if all 5 agree, so much the cheaper for them!). I hope this will meet with your approval. Before I could do this, I would need:

- 1. Costing of the position
- 2. Clarity about how to organise translation of their monies into a salary (e.g. SPA).

I would like to create a job which involves 2.5 days at the hospital working with Rajat to educate patients (and support their treatments) and to enter data into MS databases, 0.5 days liaising with the MS society, and 2.0 days working as a research nurse with Rajat over at the ANU.

I will be guided by you as two what level nurse this should be but, granted that the aim is to attract external funding, could we aim for a level 3, do you think? I imagine this would probably help with recruitment. Whatever you decide, would it be possible to cost the position including salary, on-costs, cost of computer, and anything else that would be necessary? I could then get on and write to the companies. If they agree to fund the position, we can then let them know how to transfer their monies to us.

I gather that there is a bit of time pressure to get our requests in by the end of the year so that they make the budget considerations for next year. I am sorry about this but would be most grateful if you could get back to me about this before too long.

Thank you both very much indeed for your help with this. Please let me know if you anticipate any difficulties.

I understand where you are coming from.

The reason that the MS society was involved at all was that we wanted a way to obtain funding for an MS nurse from pharmaceutical companies, it being thought extremely unlikely that ACT Health would consider this a priority. My understanding is that if the nurse were funded through the hospital there would be a possible issue of tenure and this was therefore thought to be too risky a proposal granted the potentially tenuous nature of pharmaceutical funding. Hence the involvement of the MS society which is not hampered by the rules of tenure.

I would be delighted to get the pharmaceutical companies pay directly into a hospital SPA to fund the MS nurse if this arrangement could be found suitable from the hospital's point of view. It would certainly be much simpler from my point of view!

Is there a way we can set up such a soft-funded contract? Hopefully the funds would continue to come in so the contract would be renewable each year but of course this could not be guaranteed.

I would very much welcome your thoughts.

I know we are dealing with many issues in Neurology at present however I just wanted to advise that I have re looked at and consulted with respect to the MS Nurse and we can't support the proposal that was sent from the MS society as it currently stands. We have to be the employer of any nurse giving patient care through our services. However we can look at the MS society funding the position by providing funding deposited into an SPA for e.g but the Nurse has to be our employee to interact with patients etc and have access to our records and we also need to make sure that skills and competencies are maintained. If you want us to progress this then you may need to approach the MS Society to reconsider the provision of support for MS patients in keeping with our expectations as outlined. If this went ahead it would have to be a contracted position in line with the "soft" money and not a permanent position but only for the duration of the available funds.

Dear Tania,

At your suggestion, I have just been to see Tony Clarke who seems to have successfully negotiated an IBD nurse on the basis of pharmaceutical company money.

Is there any reason why we can't do the same thing with an MS nurse as I have been asking? Assuming not, I would suggest the following;

1. You let me know the cost of a 2-year contract for an approprite-level nurse, including all on-costs/cost of computer, etc..

2. I ask each of the four companies for 1/4 of that amount to be paid to the hospital.

3. Once we have confirmation of funding, we would advertise and appoint. This would be entirely independent of the pharmaceutical companies. I imagine the job description would involve inpatient, HITH and ambulatory care work with some community support.

4. The position would be "line-managed" in the same way that the stroke liaison nurse is (i.e. through the nursing administration, but having a strong link with medicine).

5. We set up clinic space to run in parallel with Roger Tuck's MS clinic (assuming)

this happens). The nurse will also need office space.

6. I believe that we have already applied to ACT Health for an MS nurse (but it might be worth checking that this has happened). Until ACT Health funding is assured, we cannot make the position permanent, and the employee needs to know that there will not be any question of tenure at the end of the period unless ACT Health agrees to fund the position (there is always the possibility of going back to the companies for more money if necessary too).

I would be happy to get the ball rolling if you are happy with this. Please let me know your thoughts. If you are in agreement, could you please let me know exactly how much money I should be asking each company for?
