Can I suggest we make the statement for the website a little more consumer friendly:

"When clients aged 65 and over present to a Walk in Centre for other conditions, the nurses will be able to provide the influenza vaccine, should the client wish. This will commence late April 2019 once funded influenza vaccines are available."

Re the briefing we would suggest something like:

The Walk in Centres (WiC) have agreed to participate in the program. However given their core business is minor illness or injury, the influenza vaccine will only be offered opportunistically, that is to appropriate clients who present for other reasons. It is therefore preferable that this is not specifically advertised. The WiC team is continuing to manage the relationship with the primary health care sector and do not wish to be seen as further encroaching on GPs work. The over 65's cohort when attending a GP for routine vaccine will also receive other health and screening interventions that the WiC's cannot provide. In addition, the potential demand for influenza vaccinations at the WiC may have a significant impact on wait times.

Thanks for your time on the phone today to discuss the provision of National Immunisation Program (NIP) funded influenza vaccine to people aged 65 and over who attend the WIC's.

You requested that any briefing to the Minister emphasise the view of the Cancer Ambulatory and Community Health Group was that the provision of influenza vaccine to WIC clients aged 65 and over be opportunistic, where influenza vaccine will only be offered opportunistically to clients presenting for other reasons. This was based on the sensitivity that the WIC does not want to be seen to be taking business from GPs and it is the preference that the WIC not be publicised as a place for over 65's influenza vaccination.

To facilitate this, I would appreciate it if you were able to provide me with a paragraph/ words you would like to be included in our influenza update brief to the Minister. In order to meet our timelines, could we please have your input by Monday 18 March 2019.

As part of our Flu season preparations, the influenza page on the ACT Health Website will also be updated to include information about access to influenza vaccination in 2019.

It was our intention to include the following words in the update. Please provide any comments you have on the words below:

"The WIC will offer opportunistic influenza vaccination to clients aged 65 and over presenting for medical assessment from late April in 2019, once National Influenza Program funded influenza vaccine becomes available."

I appreciate the WIC's cooperation and commitment to increasing influenza vaccination coverage rates for those aged 65 and over in our community. I look forward to your response and continuing to work with the WIC's on this initiative.

I seek your approval on a Walk in Centre Medication Standing Order as a matter of urgency – Attached

Overview

As you may be aware there has been a political decision that has come to us via the Ministers Office and Population Health Services to offer opportunistic Flu vaccination to people over the age of 65yrs under the scope of the WiC. Older adults have been identified as group who are at increased risk for complications of influenza and improving uptake of influenza vaccination in this age group has been found to improve health outcomes. Yearly influenza vaccination helps reduce the risk and severity of infection and the number of hospitalisations from flu. People over 65 should receive one of the high dose or adjuvanted trivalent influenza vaccines specially formulated to induce a greater immune response in this age group. This initiative has been encouraged and is being support by the Population Health Service who will supply the vaccine stock.

The Medication Standing Order (MSO) and Clinical Treatment Protocol (CTP) have been submitted to the DTC who have advised that they agree with the attached document however the Cho is to sign off on this.

The aim is to have opportunistic Flu vaccination for over 65 yr olds in the WiC commencing **April 2019** as soon as vaccine stocks arrive in the **ACT**.

The Population Health Service's Vaccine management Unit (VMU) staff will provide a monthly delivery to the WiCs. This will be every 4 weeks after the initial stock is delivered.
