## DECISION ON YOUR ACCESS APPLICATION

I refer to your application under section 30 of the *Freedom of Information Act 2016* (FOI Act), received originally by the Justice and Community Safety Directorate (CSD) and then transferred under Section 57, to the Canberra Health Services (CHS) on **Thursday 8 July 2021**.

This application requested access to:

'Could I have the following information under the FOI Act please as at today's date - 30 June 2021. This request is limited to the AMC ONLY. It does not cover full time Administrative staff in Civic or full time staff in Mitchell. Court Staff are covered as are Court Transport Vehicle Staff.

Staff who spend any time in the AMC are covered by this request.

Visitors, legal visitors and other casual contacts are not covered by this request.

I am an Information Officer appointed by the Chief Executive Officer of Canberra Health Services (CHS) under section 18 of the FOI Act to deal with access applications made under Part 5 of the Act. CHS was required to provide a decision on your access application by **Thursday 5 August 2021**.

Searches were completed for the relevant documents and I have identified one document holding the information within scope of your access application. My access decisions are detailed further in the following statement of reasons and the document released to you is provided as <a href="Attachment A">Attachment A</a> to this letter.

In reaching my access decision, I have taken the following into account:

- The FOI Act;
- · The contents of the documents that fall within the scope of your request; and
- The Human Rights Act 2004.

### **Decision on access**

I have decided to grant full access to the relevant information contained within the one document. Redactions have been made to information that is out of scope to your application.

CHS do not hold the other information requested in your application.

### Charges

Processing charges are not applicable to this request.

### Disclosure Log

Under section 28 of the FOI Act, CHS maintains an online record of access applications called a disclosure log. The scope of your access application, my decision and documents released to you will be published in the disclosure log not less than three days but not more than 10 days after the date of this decision. Your personal contact details will not be published.

# Ombudsman review


