DECISION ON YOUR ACCESS APPLICATION

I refer to your application under section 30 of the *Freedom of Information Act 2016* (FOI Act), received by Canberra Health Services (CHS) Wednesday 23 August 2023 and was then updated with a revised scope on Monday 28 August 2023.

This application requested access to:

"All documents prepared in relation to a media request from The Canberra Times about accreditation and training reviews sent by the control on Friday, August 18.

This request includes draft responses and correspondence relating to the request."

I am an Information Officer appointed by the Chief Executive Officer of Canberra Health Services (CHS) under section 18 of the FOI Act to deal with access applications made under Part 5 of the Act. CHS was required to provide a decision on your access application by **Tuesday 10 October 2023**.

I have identified 22 documents holding the information within scope of your access application. These are outlined in the schedule of documents included at Attachment A to this decision letter.

Decisions

I have decided to:

- grant full access to five documents; and
- grant partial access to 17 documents.

My access decisions are detailed further in the following statement of reasons and the documents released to you are provided as <u>Attachment B</u> to this letter.

In reaching my access decision, I have taken the following into account:

- The FOI Act;
- The contents of the documents that fall within the scope of your request; and
- The Human Rights Act 2004.

Full Access

I have decided to grant full access to the information in scope of your application within five documents at references 5-6, 8, 17 and 19.

Partial Access

I have decided to grant partial access to 17 documents at references 1-4, 7, 9-16, 18 and 20-22. These documents contain information that I consider, on balance, to be contrary to the public interest to disclose under the test set out in Section 17 of the FOI Act.

<u>Public Interest Factors Favouring Disclosure</u>

The following factors were considered relevant in favour of the disclosure of the documents:

- Schedule 2, 2.1 (a)(i) promote open discussion of public affairs and enhance the government's accountability; and
- Schedule 2, 2.1 (a)(ii) contribute to positive and informed debate on important issues or matters of public interest.

Public Interest Factors Favouring Non-Disclosure

The following factors were considered relevant in favour of the non-disclosure of the documents:

• Schedule 2, 2.2 (a)(ii) prejudice the protection of an individual's right to privacy or any other right under the Human Rights Act 2004.

Documents at references 1-4, 7, 9-16, 18 and 20-22 have redactions to personal information such as mobile numbers and email addresses of ACT Government employees and non-ACT Government employees that has not been disclosed as this could reasonably be expected to prejudice the protection of the individual's right to privacy.

On balance, the information identified factors favouring disclosure were outweighed by the factors favouring non-disclosure as I have determined that the information would be expected to prejudice involved individuals' right to privacy therefore, I determined the information identified is contrary to the public interest and have decided not to disclose this information.

Charges

Processing charges are not applicable to this request.

Disclosure Log

Under section 28 of the FOI Act, CHS maintains an online record of access applications called a disclosure log. The scope of your access application, my decision and documents released to you will be published in the disclosure log not less than three days but not more than 10 days after the date of this decision. Your personal contact details will not be published.

Ombudsman review

My decision on your access request is a reviewable decision as identified in Schedule 3 of the FOI Act. You have the right to seek Ombudsman review of this outcome under section 73 of the Act within 20 working days from the day that my decision is published in ACT Health's disclosure log, or a longer period allowed by the Ombudsman.

Attributable to a Canberra Health Services (CHS) spokesperson:

This year's Budget invests more than \$8 million to improve the wellbeing of our Junior Medical Officers. This includes expanding pastoral support for young doctors and putting a new Director of Clinical Training to help with the coordination of recognised training programs that occur within CHS.

Training accreditation is a continuous cycle of review and re-accreditation. This includes ongoing monitoring in between to inform this process. We welcome these key opportunities to have external review and continual improvement of the learning environments in our hospitals.

Are any other training programs at Canberra Hospital under review by a specialist college or accreditor outside of the regular cycle?

Are any other training programs at North Canberra Hospital under review by a specialist college or accreditor outside of the regular cycle?

Have any training programs, other than those previously reported, been suspended or cancelled at either hospital in 2023? This is either by accreditors or the hospitals themselves.

We are not aware of other training accreditation programs at Canberra Hospital or North Canberra Hospital under review by a specialist college or accreditor, other than those recently reported on. No other training programs at either hospital have been suspended in 2023.

CHS has written to the ACT Branch of the Australian Medical Association to ask them to provide details on any additional information they have regarding college accredited programs at risk of suspension, so that appropriate measures can be considered where these areas have not been identified.

Which specialist colleges or accreditors have contacted Canberra Hospital seeking further information about training programs, outside of the regular cycle?

There have been no other known approaches outside the regular cycle at either hospital in 2023. Training accreditation is a continuous cycle, and we work closely with speciality colleges on an ongoing basis as part of core business.

For example, in March 2022, following a visit by the Royal Australasian College of Surgeons (RACS), CHS were not accredited for an Early Surgical Educational and Training (SET) trainee for Paediatric Surgery. In May this year, following a follow-up visit by the college and extensive work to address the college's feedback from the previous year, CHS was re-accredited for one SET trainee for five years. The college provided the following feedback:

"The Executive and Paediatric Surgeons have responded in a positive fashion to the concerns of the Committee described in the previous out of cycle accreditation visit and deserve recognition for their considerable efforts. They have addressed each of the concerns raised, have kept the Committee appraised of their progress and have a structure which would enable an appropriate learning environment for a SET Trainee."

In addition, another example is work that has been underway with the Royal Australian College of Physicians (RACP) on Cardiology at Canberra Hospital to ensure the department continues to meet its accreditation requirements, following the changes underway in recent years to improve both the culture and operating model for cardiology services.

What programs are scheduled for a review this year?

CHS is advised by the individual speciality colleges immediately prior to planned visits. At this stage, we are not aware of any planned visits, although individual units may have had some preliminary discussions with colleges about upcoming visits.

Please see below the proposed response to the CT media enquiry on training accreditation for MO review and approval. I have emailed this morning to let her know that we would be late with the response...

As discussed yesterday, I am still waiting for NCH to respond to the last question. I am hoping I get this through early this morning, so we can incorporate into the response before we go back to If not, I will call to let her know we are answering about CH only to get them a response as quickly as possible, and that NCH response is coming.

Attributable to a Canberra Health Services (CHS) spokesperson:

This year's Budget invests more than \$8 million to improve the wellbeing of our Junior Medical Officers. This includes expanding pastoral support for young doctors and putting a new Director of Clinical Training to help with the coordination of recognised training programs that occur within CHS.

Training accreditation is a continuous cycle of review and re-accreditation. This includes ongoing monitoring in between to inform this process. We welcome this process as a key opportunity to review and improve the learning environments in our hospitals.

Are any other training programs at Canberra Hospital under review by a specialist college or accreditor outside of the regular cycle?

Are any other training programs at North Canberra Hospital under review by a specialist college or accreditor outside of the regular cycle?

Have any training programs, other than those previously reported, been suspended or cancelled at either hospital in 2023? This is either by accreditors or the hospitals themselves.

We are not aware of other training accreditation programs at Canberra Hospital or North Canberra Hospital under review by a specialist college or accreditor, other than those recently reported on. No other training programs at either hospital have been suspended in 2023.

CHS has written to the ACT Branch of the Australian Medical Association to ask them to provide details on any additional information they have regarding college accredited programs at risk of suspension, so that appropriate measures can be considered where these areas have not been identified.

Which specialist colleges or accreditors have contacted Canberra Hospital seeking further information about training programs, outside of the regular cycle?

Which specialist colleges or accreditors have contacted North Canberra Hospital seeking further information about training programs, outside of the regular cycle?

There have been no approaches outside the regular cycle at either hospital. Training accreditation is a continuous cycle, and we work closely with speciality colleges on an ongoing basis throughout the year.

For example, in March 2022, following a visit by the Royal Australasian College of Surgeons (RACS), CHS were not accredited for an Early Surgical Educational and Training (SET) trainee for Paediatric Surgery. In May this year, following a follow-up visit by the college and extensive work to address the college's feedback from the previous year, CHS was re-accredited for one SET trainee for five years. The college provided the following feedback:

"The Executive and Paediatric Surgeons have responded in a positive fashion to the concerns of the Committee described in the previous out of cycle accreditation visit and deserve recognition for their considerable efforts. They have addressed each of the concerns raised, have kept the Committee appraised of their progress and have a structure which would enable an appropriate learning environment for a SET Trainee."

In addition, another example is work that has been underway with the Royal Australian College of Physicians (RACP) on Cardiology at Canberra Hospital to ensure the department continues to meet its accreditation requirements, following the changes underway in recent years to improve both the culture and operating model for cardiology services.

What programs are scheduled for a review this year?

CHS is advised by the individual speciality colleges immediately prior to planned visits. At this stage, we are not aware of any planned visits, although individual units may have had some preliminary discussions with colleges about upcoming visits.

Attributable to a Canberra Health Services (CHS) spokesperson:

This year's Budget invests more than \$8 million to improve the wellbeing of our Junior Medical Officers. This includes expanding pastoral support for young doctors and putting a new Director of Clinical Training to help with the coordination of recognised training programs that occur within CHS.

Training accreditation is a continuous cycle of review and re-accreditation. This includes ongoing monitoring in between to inform this process. We welcome these key opportunities to have external review and continual improvement of the learning environments in our hospitals.

Are any other training programs at Canberra Hospital under review by a specialist college or accreditor outside of the regular cycle?

Are any other training programs at North Canberra Hospital under review by a specialist college or accreditor outside of the regular cycle?

We are not aware of other training accreditation programs at Canberra Hospital or North Canberra Hospital under review by a specialist college or accreditor, other than those recently reported on. No other training programs at either hospital have been suspended in 2023.

CHS has written to the ACT Branch of the Australian Medical Association to ask them to provide details on any additional information they have regarding college accredited programs at risk of suspension, so that appropriate measures can be considered where these areas have not been identified.

There have been no other known approaches outside the regular cycle at either hospital in 2023. Training accreditation is a continuous cycle, and we work closely with speciality colleges on an ongoing basis as part of core business.

For example, in March 2022, following a visit by the Royal Australasian College of Surgeons (RACS), CHS were not accredited for an Early Surgical Educational and Training (SET) trainee for Paediatric Surgery. In May this year, following a follow-up visit by the college and extensive work to address the college's feedback from the previous year, CHS was re-accredited for one SET trainee for five years. The college provided the following feedback:

"The Executive and Paediatric Surgeons have responded in a positive fashion to the concerns of the Committee described in the previous out of cycle accreditation visit and deserve recognition for their considerable efforts. They have addressed each of the concerns raised, have kept the Committee appraised of their progress and have a structure which would enable an appropriate learning environment for a SET Trainee."

In addition, another example is work that has been underway with the Royal Australian College of Physicians (RACP) on Cardiology at Canberra Hospital to ensure the department continues to meet its accreditation requirements, following the changes underway in recent years to improve both the culture and operating model for cardiology services.

What programs are scheduled for a review this year?

CHS is advised by the individual speciality colleges immediately prior to planned visits. At this stage, we are not aware of any planned visits, although individual units may have had some preliminary discussions with colleges about upcoming visits.






Have any training programs, other than those previously reported, been suspended or cancelled at either hospital in 2023? This is either by accreditors or the hospitals themselves.

We are not aware of other training accreditation programs at Canberra Hospital or North Canberra Hospital under review by a specialist college or accreditor, other than those recently reported on. No other training programs at either hospital have been suspended in 2023.

CHS has written to the ACT Branch of the Australian Medical Association to ask them to provide details on any additional information they have regarding college accredited programs at risk of suspension, so that appropriate measures can be considered where these areas have not been identified.

Which specialist colleges or accreditors have contacted Canberra Hospital seeking further information about training programs, outside of the regular cycle?

Which specialist colleges or accreditors have contacted North Canberra Hospital seeking further information about training programs, outside of the regular cycle?

There have been no other known approaches outside the regular cycle at either hospital in 2023. Training accreditation is a continuous cycle, and we work closely with speciality colleges on an ongoing basis as part of core business.

For example, in March 2022, following a visit by the Royal Australasian College of Surgeons (RACS), CHS were not accredited for an Early Surgical Educational and Training (SET) trainee for Paediatric Surgery. In May this year, following a follow-up visit by the college and extensive work to address the college's feedback from the previous year, CHS was re-accredited for one SET trainee for five years. The college provided the following feedback:
"The Executive and Paediatric Surgeons have responded in a positive fashion to the concerns of the Committee described in the previous out of cycle accreditation visit and deserve recognition for their considerable efforts. They have addressed each of the concerns raised, have kept the Committee appraised of their progress and have a structure which would enable an appropriate learning environment for a SET Trainee."
In addition, another example is work that has been underway with the Royal Australian College of Physicians (RACP) on Cardiology at Canberra Hospital to ensure the department continues to meet its accreditation requirements, following the changes underway in recent years to improve both the culture and operating model for cardiology services.
What programs are scheduled for a review this year?
CHS is advised by the individual speciality colleges immediately prior to planned visits. At this stage, we are not aware of any planned visits, although individual units may have had some preliminary discussions with colleges about upcoming visits.
