DECISION ON YOUR ACCESS APPLICATION

I refer to your application under section 30 of the *Freedom of Information Act 2016* (FOI Act), received by Canberra Health Services (CHS) on **Wednesday 21 February 2024**.

This application requested access to:

'I am advised that a comprehensive review of the operations of the nurse led walk-in centres was undertaken in 2013. Under the FOI Act I would like to be supplied with:

- a) any report regarding the review of the existing nurse walk-in centres undertaken in 2013.
- b) any report of any subsequent similar review into the operations of the 5 nurse led walkin centres that was undertaken after the 2013 review.'

I am an Information Officer appointed by the Chief Executive Officer of Canberra Health Services (CHS) under section 18 of the FOI Act to deal with access applications made under Part 5 of the Act. CHS was required to provide a decision on your access application by **Monday 22 April 2024**.

Decisions

CHS does not hold information relevant to the scope of your application, being reports regarding the review of nurse led walk-in centres in 2013 or subsequently, in accordance with section 35(1)(b) of the FOI Act.

An Independent evaluation of the nurse-led ACT Health Walk-in Centre by the Australian Primary Health Care Research Institute was performed in 2011. The report regarding this evaluation is publicly available and can be found at the following link:
