

5. New business

5.1 Use of resident names during meetings

Conrad Barr explained that after the previous meeting, several agencies advised that they cannot follow the discussions in HCMG meetings because they only know clients by their full name and not by the address.

It was agreed that the names of clients should be referred to in the meeting as well as the property address, so that all members can know which case is being referred to. Client names will not be recorded and the Minutes will identify the property by location only.

5.2 Hoarding Advocacy Support Service (HASS) trial - update

Cate delivered a presentation and paper about the 3.5-month HASS trial that will soon finish.

The HASS trial has assisted communication between support services, clients and Government. The HASS officer has helped to engage cleaners and other supports under NDIS and My Aged Care funding.

Where support was already in place, the HASS officer coordinated with, and supported, existing workers rather than trying to establish relationships directly with clients in the short timeframe of the trial.



The client has long term funding and many supports, but the services were not talking to each other (only the Mental Health Team and Housing ACT were communicating). Cate liaised with the various agencies, but not directly with the client.



Some findings from the trial

- There is great demand for HASS Cate received more than 20 enquiries over three months, but the HASS trial did not allow for other cases to be taken on.
- Multi-disciplinary planning is essential.
- Funding for small purchases builds rapport with support workers and clients and can overcome barriers.
- The inability to share client history impacts communication between stakeholders.
- Having funding in place does not guarantee that services will be accessible.
- There is a need for training of stakeholders concerning language used around hoarding and squalor issues (e.g. issues can be overlooked during NDIS or My Aged Care planning).
- There is a need for training, support and mentoring of staff working with hoarding.
- There are issues concerning confidentiality and information exchange between stakeholders assisting in hoarding cases. Information exchange was not a problem for Cate when liaising with HCMG members; but it was a problem when liaising with those outside the HCMG group.

WCS will send out a staff survey about HASS to those involved with the three clients.

Conrad said there was positive feedback from some of the neighbours. He thanked Cate for her involvement and for the update.

5.3 Litter Legislation Amendment Bill 2019

Transport Canberra and City Services discussed the Litter Legislation Amendment Bill 2019 and development of a hoarding code of practice, which will be a mandatory if the Bill is passed.

Sean explained that the Bill looks to change what triggers an offence and provide more tools for dealing with litter, including litter on private property if it affects the amenity of others.

In the event of legal action, TCCS would be able to demonstrate to a court that the steps outlined in the code of practice have been undertaken.


The code of practice should use a balanced approach to hoarding, considering the impact on neighbours as well as the mental health needs of the resident. It should align with government policy and Ministerial expectations.

Martin Berry and Steve O'Shea will be drafting the code of practice under the Litter Act. Martin said that TCCS would appreciate input from HCMG in developing the code.

The code should be a step by step guide on how to progress through a case. Development of the code will need to consider the intent, preferred framework and who to involve. It would be hard to mandate that an external agency should take part. Every case is different, so the code will need to be high-level.

Action: Secretariat to assist TCCS to convene a small working group out-of-session to discuss content of the hoarding code of practice that will be required if the Litter Legislation Amendment Bill 2019 is passed.

Hoarding is a complex social issue which has many potential causes with no simple solution.

- We recognise that people who hoard items to the point where their homes can become a health and safety risk may be experiencing a range of issues, including mental illness.
- This complex issue requires a combination of approaches including regulatory action, psychological and welfare support, and relevant Non-Government Organisation (NGO) engagement. Across ACT Government, we manage this through a Hoarding Case Management Group, which has been in place since 2015.

Information about the current hoarding services available to people in the ACT. What services are offered by ACT Health currently and how much funding is allocated to them?

- Earlier this year, the ACT Health Directorate procured the Woden Community Service to run a trial of a
 Hoarding Advocacy Support Services (HASS). The trial cost \$90,000 to run. Further details on this trial are
 below.
- Acknowledging that hoarding behaviour may be associated with a range of mental health issues, there are number of community and health services individuals can access including their general practitioner, local community service and <u>Access Mental Health</u>, which includes our Adult and Child and Adolescent Community Mental Health Teams located throughout Canberra.
- Although the vast majority of severe hoarding cases occur on privately owned residences, Housing ACT has
 team of very skilled front line specialist workers that work intensively with tenants that require additional
 support to maintain their tenancies. Housing ACT works together with tenants and support agencies to tailor
 response that takes into account individual capabilities. This work is in line with Housing ACT's Modernising
 Tenancy Services Framework, which is about ensuring a continuum of support and resources to assist
 people to engage in behavioural change.
- Each year Housing ACT also supports the Belconnen Community Services (BCS) to help the tenants of 10 properties who are at risk of eviction by volunteering basic gardening and yard clean up services. The service provides assistance to tenants experiencing difficulty maintaining their outdoor areas and is the result of strong community partnerships between employees of BCS, Housing ACT and members of our community.
- In the addition to the above, ACT Fire & Rescue (ACTF&R) regularly attends reported hoarding properties to assess the property from an operational risk perspective and promote fire safety with the occupants. As part of this service, ACTF&R offers smoke alarm installation and general fire safety advice.

How many cases of hoarding are treated each year and whether these are long-term ongoing cases?

• There is only a small number of cases of severe hoarding and squalor every year. At present the Hoarding Case Management Group is managing five cases and monitoring one previously managed case.

 or odorous material.
- Hoarding might involve the collection of items, food or animals, inside and/or outside the home.
 A hoarder may collect one or many types of things. Animal hoarding is often characterised by an inability to adequately care for the animals that have been collected.
- Squalor may be present with or without hoarding. It may involve living conditions that are dirty and unpleasant as a result of neglect, poverty or mental illness, and may involve the refusal or inability to discard of waste and undertake cleaning tasks.
- Due to the complex nature of hoarding, effective hoarding responses often require involvement of a range of Directorates and agencies. For example, one hoarding case could involve:
 - Access Canberra, if the case involves an unclean leasehold;
 - Transport Canberra and City Services, if material accumulates on public land or if there are domestic animal concerns;
 - the ACT Ambulance Service, who might bring the property to the attention of relevant Directorates;
 - Housing ACT, if it concerns a Housing ACT property;
 - ACT Fire and Rescue, if there are fire hazards that need to be rectified;
 - the Health Protection Service (HPS), to assess whether there is an insanitary condition;
 - a Mental Health Team, as the resident may be a client or may require a mental health assessment;
 - the Deputy Public Advocate, to provide information, advocacy and guidance; and
 - cleaners, pest control, the RSPCA, National Disability Insurance Scheme providers and community services.
- Without effective case management and coordination, these stakeholders can be isolated in their approach.

Hoarding Case Management Group (HCMG)

 HPS convened the Hoarding Case Management Group (HCMG) in 2015, in response to a need for cross-agency collaboration for complex cases of hoarding and domestic squalor.

SENSITIVE

- Despite this coordination role, HPS can only take action in the small proportion of hoarding cases that involve insanitary conditions under the *Public Health Act 1997*.
- HCMG meets every two months and currently oversees five complex hoarding cases.
- HCMG currently has representatives from HPS, Transport Canberra and City Services, Access
 Canberra, Housing ACT, Public Advocate, ACT Fire and Rescue, ACT Ambulance Service and Mental
 Health, Justice Health and Alcohol and Drug Services. Child and Youth Protection Services are
 available to attend if there is a relevant case.

Whole-of-Government approach to hoarding

- HPS continues to coordinate HCMG, despite no funding and no authority over most hoarding cases. Other HCMG members have been reluctant to take on the role.
- Further consideration needs to be given to the future approach to complex cases of hoarding and domestic squalor. A whole-of-government approach could be supported by a Cabinet commitment and a written framework overseen by an area of Government with cross-government leadership.
- HPS is currently preparing a brief for Minister for Health, Rachel Stephen-Smith MLA, concerning these issues.

Hoarding Advocacy Support Service (HASS)

- Woden Community Service (WCS) previously provided hoarding support to residents as usual business and had a representative on HCMG; however, they ceased hoarding work in early 2018 because they could no longer commit resources. The absence of this intensive support from the community sector had a negative impact on some hoarding cases.
- In late 2018, HCMG recognised the impact from the absence of community-sector support for complex cases of hoarding and squalor. HPS sourced funding for a short-term trial of a Hoarding Advocacy Support Service (HASS) from mid-March to 30 June 2019. Through a Request for Tender process, WCS was engaged as the preferred provider.
- No prior funding arrangement had been entered between the ACT Government and the community sector for the provision of hoarding support.
- In undertaking the trial, the HASS officer from WCS provided case management and support
 (e.g. assisting clients, enhancing communication between stakeholders, mentoring support workers
 and liaising with service providers) for the three most complex hoarding and squalor cases being
 overseen by the HCMG.
- The HASS Trial Self-evaluation Report from WCS suggested that HASS may have a positive impact on complex hoarding cases. On 20 August 2019, HCMG discussed the HASS Trial Report and is developing a response and briefs for relevant Ministers.
- For HASS to continue, a cross-government funding commitment and agreement on the appropriate lead Directorate is needed.





Minister's question/s:

On 13 December 2018, the Minister advised that the 2019/2020 budget appropriation bid to fund Non Government Organisation (NGO) provision of Hoarding Advocacy Support Services (HASS) was not supported. The Minister asked for advice on the future approach.

ACT Health's response:

Hoarding Advocacy Support Services (HASS)

The Health Directorate identified internal funding for the conduct a HASS trial for the remainder of the 2018/19 financial year. The procurement process for the HASS trial is in the final stages and the trial is expected to be conducted between February and June 2019. The outcomes of the HASS trial will be considered by the Hoarding Case Management Group (HCMG) to inform the future approach to manage all types of hoarding in the ACT.

Hoarding Case Management Working Group Options

The HCMG is scheduled to meet on 14 February 2019. An agenda paper has been drafted for the HCMG noting the outcome of the budget process and seeking member's consideration of alternate options. The options to be put to the HCMG include: a possible cost share approach between Directorates; or alternately, that each lead agency (Directorate) internally fund their own HASS costs associated with hoarding management through the HCMG.

ACT Health Options

Dependant on the outcomes of the HCMG negotiations, the Health Directorate retains a number of unilateral options to enhance support to severe hoarding cases. These options currently include:

- negotiating a variation to the existing Service Funding Agreements (SFA) with the Woden Community Service (WCS) to incorporate the delivery of HASS; or
- Establishing a permanent case management position within the Health Protection Service (HPS) to provide dedicated case management to severe hoarding and squalor cases.

Neither of these options have an identified funding source and would need to be offset by existing resources within the Health Directorate.

You will be briefed on the outcomes of the HASS trial and on the preferred options for a whole of government approach to manage all types of hoarding in the ACT going forward.

On 12 September, the Minister's advisor asked for advice on 'the expected quantum' and a brief description of services relating to the following paragraphs from the Caveat Brief:

- In February 2018, Woden Community Service withdrew from providing intensive support services to cases of hoarding managed by the Hoarding Case Management Group (HCMG) due to financial constraints. The absence of intensive Non-Government Organisation support services for
- The HPS intends to bring forward a business case for engaging non-government support services on the HCMG in 2019-2020.

ACT Health's response:

The HPS proposes to develop a 2019-20 Budget Concept Brief on behalf of the HCMG to seek resources to support a whole-of-government (WhoG) approach to hoarding and squalor in the ACT.

The HCMG is not funded and operates within existing member agency resources, with the HPS providing secretariat and case coordination support. As such, the actions that may be taken by the HCMG are limited to those actions already available to its members (i.e. members are mostly regulators, so there is a deficit of non-regulatory support interventions available to the group). The proposal seeks funding to engage Non-Government Organisation (NGO) support services to address an identified gap in the management of complex hoarding and squalor cases. NGO support services are vital to supporting and discussing options with hoarders, working with hoarders to improve their situation, and facilitate liaison between hoarders and regulators.

It is estimated NGO support services would cost about \$250,000 per year and would include, but not be limited to:

- acting as a case manager for HCMG cases (in collaboration with the relevant lead government agency);
- providing support to hoarders;
- facilitating the provision of other services (such as cleaners or gardeners);
- coordinating a multidisciplinary response; and
- liaising between the hoarder and regulator.

UNCLASSIFIED

The management of hoarding cases is resource intensive and involves significant staff time. Engaging NGO support services would reduce the resources required of government staff.

A Ministerial Brief prepared by the HPS about options for a WhoG approach to managing all types of hoarding in the ACT is currently being progressed to Minister Fitzharris's office. The brief outlines details on the Chairing of the HCMG, a WhoG Hoarding Policy and Code of Practice, and NGO Support Services.

Minister's question/s:

On 5 November the Minister asked if funding figures provided (GCB18/567) for the Woden Community Service (WCS) were solely for hoarding (services), and if so, to please explain the difference between the ACT Health funding currently provided to WCS and the additional \$250,000 forecast as required for dedicated NGO hoarding services.

ACT Health's response:

Woden Community Service (WCS)

WCS participated on the Hoarding Case Management Group (HCMG) from the group's inception in 2015. The WCS initially participated as part of their existing role in providing Supportive Tenancy Services (STS) to the community. STS is funded with support of various sources including the Federal Government and the ACT Government, Community Services Directorate (CSD). STS are provided by WCS to assist people whose tenancy is at risk or who are facing barriers in establishing a private tenancy. The WCS provided limited case management support to hoarding cases managed by the HCMG. However, in February 2018 the WCS formally advised they would withdraw from the HCMG as they considered their ongoing participation was unsustainable.

Current ACT Health Funding of WCS

ACT Health has a two current Service Funding Agreements (SFA) with the WCS, both administered by the Policy, Partnerships and Programs Division. The SFA's include:

- A Community Assistance and Support Program (CASP), with total funding in 2018-2019 \$248,659.00 GST exclusive; and
- Adult Step Up / Step Down Intensive Transitional Outreach Support (SUSD), with total funding in 2018-2019 of \$941,536.00 GST exclusive.

The CASP provides a range of basic, low intensity home and community based services for people aged under 65 who have a condition that affects their ability to carry out activities of daily living.

UNCLASSIFIED

The SUSD provides short term (three months) intensive outreach for people aged 18-64 suffering sub-acute mental illness and is a partnership program with Mental Health, Justice Health, Alcohol and Drug Clinical Services. The program also offers users after hours case management.

While individual severe hoarding cases may seek out (or be offered) services from the STS, CASP or SUSD programs, the WCS is not currently funded by any agency for the dedicated management of hoarding cases.

ACT Health's response:

Engaging Non-Government Organisation (NGO) Support Services

The HPS proposes to develop a 2019-20 Budget Concept Brief on behalf of the HCMG to seek resources to engage an NGO to support a whole-of-government (WhoG) approach to hoarding and squalor in the ACT.

The HCMG is not funded and operates within existing member agency resources, with the HPS providing secretariat and case coordination support. As such, the actions that may be taken by the HCMG are limited to those actions already available to its members (i.e. members are mostly regulators, so there is a deficit of non-regulatory support interventions available to the group). The proposal seeks funding to engage NGO support services to address an identified gap in the

management of complex hoarding and squalor cases. NGO support services are vital to supporting and discussing options with hoarders, working with hoarders to improve their situation, and facilitate liaison between hoarders and regulators.

It is estimated NGO support services would cost about \$250,000 per year and would include, but not be limited to:

- acting as a case manager for HCMG cases (in collaboration with the relevant lead government agency);
- providing support to hoarders;
- · facilitating the provision of other services (such as cleaners or gardeners);
- coordinating a multidisciplinary response; and
- · liaising between the hoarder and regulator.

The management of hoarding cases is resource intensive and involves significant staff time. Engaging NGO support services would reduce the resources required of government staff.

Woden Community Service (WCS)

WCS initially participated on the HCMG as part of their role in providing supportive tenancy services. This function is funded with support of various sources including the Federal Government.

In addition to WCS's role in providing supportive tenancy services, the WCS assisted the HCMG in managing and resolving complex hoarding cases. There is no specific funding agreement in place for WCS to perform this function. Without ongoing funding arrangements for the WCS to provide intensive support services to hoarders, the WCS considered that its participation on the HCMG was unsustainable and withdrew from the HCMG.

On 5 November you asked if funding figures provided (GCB18/567) for the Woden Community Service (WCS) were solely for hoarding (services), and if so, to please explain the difference between the ACT Health funding currently provided to WCS and the additional \$250,000 forecast as required for dedicated NGO hoarding services.

ACT Health's response:

Woden Community Service (WCS)

WCS participated on the Hoarding Case Management Group (HCMG) from the group's inception in 2015. The WCS initially participated as part of their existing role in providing Supportive Tenancy Services (STS) to the community. STS is funded with support of various sources including the Federal Government and the ACT Government, Community Services Directorate (CSD). STS are provided by WCS to assist people whose tenancy is at risk or who are facing barriers in establishing a private tenancy. The WCS provided limited case management support to hoarding cases managed by the HCMG. However, in February 2018 the WCS formally advised they would withdraw from the HCMG as they considered their ongoing participation was unsustainable.

Current ACT Health Funding of WCS

ACT Health has a two current Service Funding Agreements (SFA) with the WCS, both administered by the Policy, Partnerships and Programs Division. The SFA's include:

- A Community Assistance and Support Program (CASP), with total funding in 2018-2019 \$248,659.00 GST exclusive; and
- Adult Step Up / Step Down Intensive Transitional Outreach Support (SUSD), with total funding in 2018-2019 of \$941,536.00 GST exclusive.

The CASP provides a range of basic, low intensity home and community based services for people aged under 65 who have a condition that affects their ability to carry out activities of daily living.

UNCLASSIFIED

The SUSD provides short term (three months) intensive outreach for people aged 18-64 suffering sub-acute mental illness and is a partnership program with Mental Health, Justice Health, Alcohol and Drug Clinical Services. The program also offers users after hours case management.

While individual severe hoarding cases may seek out (or be offered) services from the STS, CASP or SUSD programs, the WCS is not currently funded by any agency for the dedicated management of hoarding cases.

Minister's question/s:

On 13 December 2018, the Minister advised that the 2019/2020 budget appropriation bid to fund Non Government Organisation (NGO) provision of Hoarding Advocacy Support Services was not supported. The Minister asked for advice on the future approach.

ACT Health's response:

Hoarding Advocacy Support Services (HASS)

The Health Directorate identified internal funding for the conduct of a HASS trial for the remainder of the 2018/19 financial year. The procurement process for the HASS trial is in the final stages and the trial is expected to be conducted between February 2019 and June 2019. The outcomes of the HASS trial will be considered by the Hoarding Case Management Group to inform the future approach to manage all types of hoarding in the ACT.

Hoarding Case Management Working Group Options (HCMG)

The HCMG is scheduled to meet on 14 February 2019. An agenda paper has been drafted for the HCMG noting the outcome of the budget process and seeking member's consideration of alternate options. The options to be put to the HCMG include: a possible cost share approach between Directorates; or alternately, that each lead agency (Directorate) internally fund their own HASS costs associated with hoarding management through the HCMG.

ACT Health Options

Dependant on the outcomes of the HCMG negotiations, the Health Directorate retains a number of unilateral options to enhance support to severe hoarding cases. These options currently include:

- negotiating a variation to the existing Service Funding Agreements with the Woden Community Service to incorporate the delivery of HASS; or
- Establishing a permanent case management position within the Health Protection Service to provide dedicated case management to severe hoarding and squalor cases.

Neither of these options have an identified funding source and would need to be offset by existing resources within the Health Directorate.
