#### **DECISION ON YOUR ACCESS APPLICATION**

I refer to your application under section 30 of the *Freedom of Information Act 2016* (FOI Act), received by ACT Health Directorate (ACTHD) on 24 October and rescoped on 6 November 2019.

This application requested access to:

"All documents exchanged between the relevant Health authority and:

- the ACT Ambulance Service;
- the Australian Federal Police, and
- the unions representing emergency services personnel e.g. ambulance, police relating to the plans to redevelop the Canberra Hospital since the date of the Cabinet decision to move the building of SPIRE to North-East sector of the hospital site, from the original proposed location where the Helipad is currently located.

I am an Information Officer appointed by the Director-General of AHD under section 18 of the FOI Act to deal with access applications made under Part 5 of the Act. AHD was required to provide a decision on your access application by **Wednesday 4 December 2019.** 

I have identified 6 documents holding the information within scope of your access application. These are outlined in the schedule of documents included at <u>Attachment A</u> to this decision letter.

#### **Decisions**

I have decided to:

- grant full access to 2 documents; and
- grant partial access to 4 documents.

My access decisions are detailed further in the following statement of reasons and the documents released to you are provided as <u>Attachment B</u> to this letter.

In reaching my access decision, I have taken the following into account:

- The FOI Act;
- The contents of the documents that fall within the scope of your request;
- The Human Rights Act 2004.

#### **Full Access**

I have decided to grant access in full to 2 documents relevant to your request.

#### **Partial Access**

I have decided to grant partial access to 4 documents. Documents at reference 1, 3, 4 and 6 contain deletions to information that I consider, on balance, to be contrary to the public interest to disclose under the test set out in section 17 of the Act. The information contained in these folios is personal information of government and non-government employees.

### Public Interest Factors Favouring Disclosure

The following factors were considered relevant in favour of the non-disclosure of the documents:

 Schedule 2.1 (a) (i) promote open discussion of public affairs and enhance the government's accountability.

### Public Interest Factors Favouring Non-Disclosure

The following factors were considered relevant in favour of the non-disclosure of the documents:

Schedule 2, 2.2(a)(ii) prejudice the protection of an individual's right to privacy or any other right under the *Human Rights Act 2004*.

ACTHD was the lead on the Surgical Procedures, Interventional Radiology and Emergency (SPIRE) project until 1 July 2019. During this time, ACTHD held a meeting with ACTAS in March 2019, and discussions included the potential route of ambulance and emergency access. In regard to the presentation released as part of this FOI, it is a point in time representation of early design. The design of SPIRE has continued to progress such that these early designs do not represent the final design of SPIRE.

ACTHD and Major Projects Canberra have both consulted numerous stakeholders to inform service and infrastructure planning on the Canberra Hospital campus, including the scope of SPIRE. Major Projects Canberra, as the SPIRE project lead, will continue to consult with key stakeholders including the ACT Ambulance Service as the design of SPIRE is finalised.

#### <u>Charges</u>

Processing charges are not applicable to this request.

#### Disclosure Log

The scope of your access application, my decision and documents released to you will be published in the disclosure log not less than three days but not more than 10 days after the date of this decision. 




# SITE ANALYSIS URBAN CONTEXT - SITE ACCESS & CIRCULATION














## Considerations

- -Increased carparking
- Reduced pedestrian safety around drop-off/pick-up, bus stop and vehicles reversing from 60° parks
- Possible requirement for bollards if the entire zone is raised with ramps at both ends
- Reduced forecourt/plaza size to accommodate car parking
- Narrower turn paths to accommodate additional parking and pick-up/drop-off
