Freedom of Information Request - FOI18-80

I refer to your application received by ACT Health on 17 September 2018 in which you sought access to information under the *Freedom of Information Act 2016* (the FOI Act).

In your application you have requested:

"...documents containing information about all reports of lost or stolen Schedule 4 and Schedule 8 medications in ACT hospitals (both public and private) from 2013-2018 including details 1) date 2) hospital concerned 3) drug name 4) quantity missing."

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

ACT Health was required to provide a decision on your access application by 6 November 2018.

Decision on access

Eighteen documents identified as relevant to your request contain information that I consider to be information that would, on balance, be contrary to the public interest to disclose under the test set out in section 17 of the Act.

I have decided to grant access, under section 50 of the Act, to copies of these documents with deletions applied to information that I consider would be contrary to the public interest to disclose.

I have decided to refuse access to one document as I consider the document to be contrary to the public interest information under schedule 1 of the Act.

My access decisions are detailed further in the following statement of reasons and the documents release to you are as <u>Attachment A</u> to this letter.

In reaching my access decision, I have taken the following into account:

- The FOI Act
- The contents of the documents that fall within the scope of your request
- The views of relevant third parties; and
- The Human Rights Act 2004

My reasons for deciding not to grant access to the identified documents and components of these documents are as follows.

Folio 3 of the identified documents is entirely composed of, or contains information that is considered to be contrary to the public interest to disclose under schedule 1.1A of the Act. The information contained in the document relates to the reporting of an anomaly in the drug register at a Canberra hospital. The information contained in the document is in the possession of a court of tribunal. The release of this information could have an adverse effect on a judicial process and is therefore taken to be contrary to the public interest to be released.

Folios 1-2 and 4-19 of the identified documents are composed of, or contain information that I consider, on balance, to be contrary to the public interest to disclose under the test set out in section 17 of the Act as the information contained in these folios is personal information about individuals.

I have identified that there are no factors favouring disclosure of this information under Schedule 2, section 2.1 and I have identified that the following factor favours non-disclosure:

• Schedule 2 2.2 (ii) - prejudice the protection of an individual's right to privacy or any other right under the *Human Rights ACT 2004*.

On balance, the information identified is contrary to the public interest and I have decided not to disclose this information.

Information held by ACT Health and Canberra Health Services in regards to reporting discrepancies of schedule 4 medications is entirely contained in a heath record, as defined in the *Health Records (Privacy and Access) Act 1997* (HR Act).

Section 12 of the FOI Act states that this Act does not apply to information held in a health record under the HR Act. Therefore, information concerning schedule 4 medications cannot be disclosed in a Freedom of Information process.

Charges

Processing charges are not applicable to this request because the total number of documents released is less than 50 pages.

Online publishing - disclosure log

Under section 28 of the Act, ACT Health maintains an online record of access applications called a disclosure log. Your original access application, my decision and documents released to you in response to your access application will be published in the ACT Health disclosure log not less than three days but not more than 10 days after the date of this decision. Your personal contact details will not be published.

Ombudsman review

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act. You have the right to seek Ombudsman review of this outcome under section 73 of the Act within 20 working days from the day that my decision is published in ACT Health's disclosure log, or a longer period allowed by the Ombudsman.

Dear Pharmaceutical Services,

The Pharmacy Department at Canberra Hospital has a discrepancy in its register for Targin (oxycodone/naloxone) 2.5mg/1.25mg.

There is one tablet that is unaccounted for.

In reviewing this incident, staff recall hearing a tablet drop when counting the tablets this morning. No tablet can be found, but several worn foils of Targin were identified. It is possible that a tablet came loose from one of these strips.

An incident has been reported (number

Any worn strip of Targin has been destroyed, preventing similar loss in the future.

It is not my belief that this medication has been diverted.

Hi Stuart

My apologies for not contacting you. The incident happened after 4pm (1838hrs) and I wasn't aware that you were not notified. I will in future call you myself as soon as I am aware of the incident. I will also re-educate my staff to ensure that you are notified of all missing S8/S4 drugs in my absence.

As I stated in the RISKMAN a thorough investigation was conducted.

I feel that potentially the drug could have fallen into the bin as the cupboard was full and the ampoules were loose. The bin was directly under the cupboard and the bags had been removed by the cleaners when the final count of the day was conducted. Staff were unable to locate the garbage bags to check.

Hi there,

I would like to report an incident in relation to dexamphetamine supply that occurred on Friday 22nd September 2017 at around 11 am. A new (sealed) bottle of dexamphetamine was opened to fulfil a ward request for 50 tablets of dexamphetamine for an inpatient. When the balance of the bottle was counted, there was only 49 tablets left in the bottle. The count was triple checked with a technician and 2 dispensary pharmacists, plus a search in the dispensary to make sure there was none lost during the repacking of the dexamphetamine tablets to the required quantity.

I made a phone call the Aspen pharmaceutical to report the above matter (Incident report reported Dexamphetamine batch number #CL772; Expiry 10/2018.



Missing Dexamfetamine tablet from Calvary Public hospital pharmacy Dept.

Sequence of events (as per phone conversation with

27/9/2017 - 11:20am)

- 1. Request for 50 tablets to ward.
- 2. To be distributed as 5 bottles of 10 tablets repackaged into plastic vials.
- 3. Only 12 plus 8 tablets opened in safe to use, therefore decision to use new bottle made to remain consistent with batch numbers.
- 4. Full bottle removed from safe by Pharmacist and given to dispensary technician to record batch and expiry date into i-pharmacy for labelling.
- 5. Full and still sealed bottle given to pharmacist to decant 10 tablets into each of the 5 bottles.
- 6. Upon counting remaining stock to balance register, noted only 49 tablets remained in bottle.
- 7. Pharmacist re-counted decanted tablets and correct.
- 8. Pharmacist re-counted remaining tablets and still only 49.
- 9. Pharmacist called upon a HP3 pharmacist to double check and confirmed the same.
- 10. Technician double checked and confirmed the same.
- 11. Checked surrounding floor, bin and table for any loose missing tablets. None found.
- 12. Nurse collecting decanted bottles of 10x5, also checked and quantity was right.
- 13. Confirmed with pharmacist there was no time the unopened dexamfetamine tablets were left unattended from pharmacist presence.
- 14. Pharmacist phoned Aspen and was advised that sometimes it happens that a bottle is missing a tablet. Incident report number given (#COM17/01260) for batch #CL772 and expiry 10/2018.
- 15. Aspen will not investigate further for a 1 tablet loss, only if larger numbers e.g. 10-20 are missing from a bottle.

Follow-up

No further follow up required. Calvary Public Hospital Pharmacy Department advised to ensure their controlled medicines register reflects a tablet is missing and that the matter has been reported to HPS and Aspen.

As per our conversation this morning I am notifying you of a discrepancy in the count for liquid hydromorphone of 36.5ml (from a bottle of 473ml). I don't believe that this is an issue with staff diverting the drug. I think that it relates to the way we dispense the medication.

A Riskman was logged on 22/8 and no errors in the count were found on review of the log. It is being caused by our inability to measure the liquid accurately as there are no increments on the bottles and when we dispense the drug there is no cap on the bottles and we need to pour it into medication cups to dispense it losing a small amount of medicine every time.

I will email main pharmacy to see if the drug can be decanted into bottles with measurement gradients on the side and a dispensing cap.

On Tuesday 11 July 2017 a discrepancy was identified in the Controlled Medicine count on Ward

One Targin (oxycodone/naloxone 10/5mg) tablet is unable to be accounted for

Summary:

- At 0650hrs on Tuesday 11 July 2017 two Registered Nurses conducted a Controlled Medicine count and recorded in the Drug Register – 57 tablets of Targin 10/5mg "checked and correct"

At ~1400hrs two Registered Nurses commenced a Controlled Medicine count and found that there were 56 tablets of Targin 10/5mg (2 sealed boxes of Targin 10/5mg and one box with one empty blister sheet – total 56 tablets), there was no record of Targin 10/5mg being dispensed since prior check

At ~1530hrs CBPH After Hours Hospital Manager (AHHM) was informed by Ward staff that there was a discrepancy in the Controlled Medicine count

- AHHM and Ward staff checked the medication safe and confirmed there were 56 tablets present

- The medication room and medication safe were searched

The missing tablet was not located

- The Drug Register was amended to record 56 tablets "balance corrected" at 1610hrs

Actions taken:

- On Tuesday 11 July 2017 at ~1730hrs, AHHM reported discrepancy to Ms

On Wednesday 12 July 2017 commenced an investigation

- At ~1530hrs and and reviewed the medication safe, medication room, Drug Registers and patient medication charts and were unable to identify the missing medication

- At ~1535hrs reported the missing medication to Mr Kapil Parikh, ACT Chief Pharmacist

- At ~1630hrs reported the missing medication to ACT Policing, as per CBPH policy (Ref:

no. 21142, Belconnen Police)

s investigation findings:

"There were four staff directly involved in the incident as they are the nurses who did the morning and afternoon shift S4 & S8 drug count checks and discovered the discrepancy.

- I have written statements from two of them & the AHNM on duty for that shift summarising the incident. I
 am still waiting for statements from two more nurses.
- Consultation was done with all staff directly involved in the count for the S8 drugs during handover times
 on the 11th July. The AHNM on duty at the time of the incident did a complete check of the medication
 cupboard and medication room in an attempt to locate the missing tablet.
- On 12 July @ 1530 hrs myself and the medication administration during the morning shift to confirm that there was no medication recording error.
- Review of the medication charts and S8 medication book for Targin 10/5mg did not disclose any medication administration or count error.
- After the preliminary investigation and studying the staff statements, I am of the opinion that the tablet has fallen out of the original packaging as it was not intact when the morning shift count was done."

Dear Chief Health Officer (ACT)

I am writing to you to officially report an incident involving controlled drugs at Epic Pharmacy, Calvary John James Hospital in Deakin (173 Strickland Crescent, Deakin 2600).

This matter involves the incorrect stock quantities of two controlled drugs, ketamine 200mg/2ml ampoules (Ketalar brand) and fentanyl 500mcg/10ml ampoules (GH brand). The following table outlines the details.

| Controlled drug | Physical quantity | Drug register quantity | Discrepancy | Date discrepancy found | Last checked and correct |
|-------------------------|----------------------|------------------------|-------------|---|--|
| Ketamine 200mg/2ml | 35 | 40 | -5 | Monday the 1st of May 2017 | Wednesday the 19 th of April |
| Fentanyl 500mcg/10ml | 255 | 250 | 5 | Monday the 1 st of May 2017 | Wednesday the 26 th of April |

I believe the error was as result of a picking error (ie supplied a box of ketamine in place of fentanyl) and not of any malicious intent.

The steps taken in attempt to rectify the discrepancy has involved checking of all invoices and requisitions to ensure correct quantities received and supplied since the last checked and correct. I have also contacted the relevant managers and staff of our theatres and clinics who receive these products and have been informed that there has been no reported differences. It is possible that the quantities entered into the registers in theatres or clinics may have been based on physical stock received, not according to the requisition forms sent from the pharmacy.

In order to confirm those quantities, I have requested the recipients to provide the amount of ketamine and fentanyl received between the days 19th of April and 26th of May. Quantities have been confirmed with some locations but I am still waiting to hear back from others.

In order to meet the incident reporting requirements of 7 days from the incident found, I am reporting this matter before further follow up. Should the matter resolve, I will contact you again to notify you of the details.

To prevent this type of incident happening in the future, all controlled drug orders will undergo a second check by another pharmacist before release.

I have discussed this matter with a HPS pharmacist Kapil. Should you need further details, please do not hesitate to contact me.

Dear Kapil,

It has been brought to my attention that the balance of oxycodone 5mg tablets (Endone) in the Intensive Care Unit is 10 tablets less than expected.

This incident has been reported through Riskman (incident ID 519273).

On Tuesday morning at shift change, the balance of the oxycodone 5mg tablets was 68, when the register indicated that 78 should be present.

A search of the area was conducted, but the stock was not found.

A review of all transactions in the register indicated that the count had been correct that morning when oxycodone was administered to a patient. There were no transactions involving any controlled medicine between that time and when the safe was counted.

The team leader from the night shift was contacted but neither they, nor other staff could confidently say who had been holding the keys to the safe during the morning.

At this point, I would like to point out this discrepancy. I will follow up with some of the staff involved when possible and see if I can obtain further details.

Please let me know whether this needs to be notified to the police or others - I cannot find clear guidance in the regulations.

Hope you had a nice festive break.

I wanted to inform Pharmaceutical Services of a potential case of diversion of Morphine in our . At 6.45am on 12th Jan, staff accessed a 10mg/ml vial from the safe for patient treatment, and found it was damaged and was dry/empty. The vial was reviewed today and there was consensus that the damage is somewhat suspicious and may have been tampered with. The alternative is that it was damaged during manufacture, transportation and/or storage.

The Department CNC and I have reviewed all remaining stock of both S8 and S4D medications and found no other evidence of damage/tampering. We have also reviewed the drug registers to verify recent patient usage and to look for any suspicious entries and all records seem legitimate. The Department CNC is in the process of reviewing the staff roster for the shift when the incident was reported and will speak directly with staff involved as soon as possible. A senior Consultant within the Department (and with an interest in drug diversion) has offered to examine the vial further and potentially investigate replicating the damage.

Could you please advise if there is any further information you need at this stage or if this incident needs to be reported elsewhere. And what further, if anything, you would like to be informed of as our investigation continues.

Following up on our conversation following the discovery of S8 Drug anomalies, I understand that the actions we have agreed on are:

- All nursing staff who worked between 5th-13th June will be interviewed by yourself and the CDN Rob Jensen
- A scripted process will identify the issue and inform staff of the consequences of the theft (reported to Chief Pharmacist, Chief Nurse and AFP)
- You will offer all staff the opportunity for self disclosure with the support of EAP and a clear understanding of you responsibilities in reporting to authorities
- A scripted set of questions around S8 medication legislation will be asked (please provide)
- All nursing staff will be required to read and sign off that they have read and understand the Controlled Medicines (schedule 8) SOP, Patient's Own Medication Management SOP and Section 9 of the PSM Act 1994
- All patients own medication will be returned to family on the day of admission (if this is not possible, they
 will be placed in the Pts Own Cupboard and Checked with the S8 checks at shift changes)
- The S8, S4 and Pt's Own drug cupboard keys will be independent of any other keys
- The S8, S4 and Pt's Own drug cupboard keys will be held by the Team Leader and identified in the daily work book
- Medication safety will be discussed at every ward meeting and staff will be informed of legislation through this formal channel
- A summary of your findings following the interview process will be provided to the ADON/DON/Director of Pharmacy
- EAP will be offered to staff through the interview process and at ward meetings
