Canberra Hospital's new Surgical Procedures, Interventional Radiology and Emergency Centre will be larger and deliver more services for Canberrans as a result of ACT Government investment announced today.

SPIRE, which is the largest health infrastructure project in the ACT, will transform the Canberra Hospital campus and the acute health services delivered at the hospital and will be complemented by a new Australian National University building that will significantly boost the teaching, training and research presence on the Hospital campus.



Features of SPIRE

The scope of the new Surgical Procedures, Interventional Radiology and Emergency Centre (SPIRE) at the Canberra Hospital has been expanded following extensive consultation with the clinical workforce over the past 12 months. The new Centre will deliver more services for the community in a purpose-built facility.

The expanded scope means SPIRE will include:

- 148 beds and 22 theatres,
- a new and expanded Intensive Care Unit including paediatric intensive care,
- a new and expanded Coronary Care Unit including interventional cardiology services,
- a new and expanded Emergency Department, and
- integrated radiology and medical imaging facilities.

Many of the key aspects of SPIRE have been boosted, with this state-of-the-art critical care and surgical facility able to meet the acute healthcare needs of our growing and ageing community well into the future.

The construction of SPIRE is anticipated to be completed in 2023-24.

Intensive Care Unit

The new Intensive Care Unit (ICU) will expand from the originally planned 48 beds to 60. This is 12 more beds and will double what is currently available.

The new expanded ICU will include:

- 4 specialist paediatric beds, originally part of the expansion of the Centenary Hospital for Women Children,
- A new family zone that will provide families who have children in the ICU access to a support area including a lounge and play area,
- a rehabilitation gymnasium to provide early, integrated rehabilitation to get ICU patients moving to assist in their recovery,
- a dedicated pod of beds which can be converted into a complete isolation pod in the event of an infectious threat, and
- dedicated critical care bays, which will enable high-end, complex interventions, reducing the need to transfer these patients to interstate facilities.

Emergency Department

The new Emergency Department (ED) will have 114 treatment spaces – 39 more than currently available at Canberra Hospital. In addition, the new ED will include:

- · 4 behavioural assessment rooms,
- bariatric and superbariatric treatment spaces,
- · a separate paediatrics stream treatment area, and
- other consultation and procedural areas, including specific waiting areas for treatment streams.

Furthermore 10 Mental Health Short Stay Unit treatment spaces will be provided in SPIRE.

Coronary Care Unit

The expanded Coronary Care Unit will include:

- · 24 acute cardiac care beds, including bariatric and isolation beds,
- 4 Interventional cardiac laboratories, including one hybrid cardiac laboratory and one electrophysiology laboratory, and
- · 27 interventional unit day beds.

Surgical and medical imaging facilities

SPIRE will increase the number of theatres at Canberra Hospital from 13 to 22 – two more than originally planned for the project. This will include state-of-the-art hybrid and interventional radiology theatres to allow the latest advances in medical technology to be used.

SPIRE will add to the medical imaging facilities available at Canberra Hospital, with:

- 2 new X-ray machines,
- 3 CT Scanners, and
- an MRI machine.

SPIRE will also include more inpatient wards with 64 beds for overnight care and storage spaces for important medical equipment.

Teaching and learning

- SPIRE will also deliver 22 new state-of-the-art operating theatres an increase from the 13 currently available and two more than originally planned. Theatres in SPIRE will include hybrid theatres and interventional radiology theatres that will allow for advances in the use of medical technology and techniques.
- As part of the <u>feasibility</u>, <u>planning and design-planning and feasibility</u> work that has been under<u>taken</u>way, there has been extensive engagement with the clinical workforce, <u>and and this will-continue</u> in 2019 and beyond as early-design work progresses.
- We will be working closely with our other Directorate partners, such as
 Environment Planning and Sustainable Development Directorate and
 Transport Canberra and City Services, to explore broader planning implications for the health precinct at Garran and surrounding areas.

Key / background information

- The budget includes a provision for the estimated construction costs of SPIRE, which
 will not be separately published so as to avoid releasing commercially sensitive

I have not included the Service Delivery Plan element in this draft, and I would like to discuss further with the team – if we use the SDP example from UCPH, there are a series of strategies/plans which need to be developed as part of the SDP, i.e.:

- · Workforce Strategy;
- · Risk Management Strategy;
- ICT Strategy;
- Recurrent cost plan.

The ACT Government recently announced the <u>SPIRE Centre Project scope</u> in the lead up to the 2019-20 ACT Budget. ACT Health is now focused on completing preliminary design in preparation for construction procurement and is seeking a suitably qualified and experienced consultant to support the health planning requirements for the next phase of the SPIRE Centre Project. The project scope and schedule of accommodation is outlined at <u>Attachment A</u>.

The successful consultant will be required to:

- Critically review health planning documentation developed to-date, including the SPIRE
 Centre Detailed Business Case, draft Models of Care, Health Planning Unit Briefs and Proof of
 Concept design documentation;
- Undertake targeted workshops with clinical and non-clinical stakeholders within Canberra
 Health Services and ACT Health to identify any opportunities to develop, improve or realign
 Models of Care and Models of Service Delivery (for non-clinical or clinical support services)
 with a contemporary operational or infrastructure solution. This may also include
 consultation with key consumer reference groups;
- Develop for consideration by the Canberra Health Services executive leadership final Models
 of Care and Health Planning Unit Briefs for the identified services, noting that in most cases
 this will be a process of updating existing documentation;
- Referencing the Models of Care and Models of Service Delivery, Health Planning Unit Briefs and Proof of Concept design documentation, develop a SPIRE Centre Functional Brief

In order to maintain the SPIRE Centre delivery program, these documents will be required as reviewed and endorsed documents by 30 September 2019. Respondents are required to outline a clear program to deliver the outcomes, including the key clinical and executive workshops and review milestones.

The functional areas for the SPIRE Project include:

- · Emergency Department;
- Mental Health Short Stay Unit;
- Intensive Care Unit;
- Perioperative and Interventional Centre;
- Acute Coronary Care Unit;
- Diagnostic Imaging (Satellite);
- Surgical Inpatient Unit;
- Central Sterilising Services Department;
- Helicopter Retrieval Service;
- · Loading Dock; and
- Main Entry and Reception.

Models of Care/ Service Delivery

Draft Models of Care and Health Planning Unit Briefs were completed in early 2018 to inform business case development for the SPIRE Centre, the existing Model of Care documentation includes:

- Emergency Department;
- Mental Health Short Stay Unit;
- Intensive Care Unit;
- Perioperative and Interventional Centre;
- · Diagnostic Imaging; and
- Acute Coronary Care Unit.

In addition to any changes to clinical service delivery, these Models of Care will need to be updated to reflect the new SPIRE Centre location and high-level scope. In addition to the Models of Care, a Model of Service Delivery will need to be completed for Sterilising Services with the service moving from off-site to integrated delivery.

The ACT Health Model of Care template is at <u>Attachment A</u>, and the documents referenced above will be provided to the successful consultant on engagement.

Health Planning Unit Briefs

Similarly to the Models of Care, HPU Briefs were developed to inform the SPIRE Centre business case, including:

- Emergency Department;
- · Mental Health Short Stay Unit;
- Intensive Care Unit;
- Perioperative and Interventional Centre;
- Diagnostic Imaging;
- · Acute Coronary Care Unit;
- Helipad Retrieval;
- Sterilising Services; and
- Loading Dock.

In addition to the development of any other required HPU Briefs (i.e. Main Entry and Reception), these HPU Briefs will need to be updated to reflect any updates to the Models of Care and the Sterilising Services Model of Service Delivery.

The ACT Health HPU Brief template is at <u>Attachment A</u>, and the documents referenced above will be provided to the successful consultant on engagement.

Functional Brief

A comprehensive functional brief, summarising the Models of Care, Models of Service Delivery and HPU Briefs, is required for the SPIRE Centre project, with sufficient detail to inform detailed design and construction procurement. Consistent with previous ACT Health projects, the Functional Brief will need to include at a minimum:

- Introduction, including:
 - Description of service;
 - Future service profile;

- Overarching functional relationships, operational policy principles and design requirements;
- General design requirements; and
- Schedules of accommodation.
- For each functional area:
 - Description (including Model of Care outline for clinical functions);
 - Specific operational policies and design requirements;
 - Functional relationships;
 - Staff profile;
 - Changes to existing practice; and
 - Schedule of accommodation.

Features of SPIRE at Canberra Hospital



Building Health Services Program



SPIRE will include:

- · 148 beds and 22 theatres
- a new and expanded Intensive Care Unit including paediatric intensive care
- a new and expanded Coronary Care Unit including interventional cardiology services
- · a new and expanded Emergency Department
- integrated radiology and medical imaging facilities.

Many of the key aspects of SPIRE have been boosted, with this state-of-the-art critical care and surgical facility able to meet the acute healthcare needs of our growing and ageing community well into the future.

SPIRE will be built at the eastern end of the hospital campus. The construction of SPIRE is anticipated to be completed in 2023-24.

The new Surgical Procedures,
Interventional Radiology and Emergency
Centre (SPIRE) at the Canberra Hospital
has been expanded following extensive
consultation with the clinical workforce
over the past 12 months. The new
Centre will deliver more services for the
community in a purpose-built facility.

Intensive Care Unit

The new Intensive Care Unit (ICU) will have 60 beds – double what is currently available.

The ICU will include:

- 4 specialist paediatric beds, originally part of the expansion of the Centenary Hospital for Women Children,
- a new family zone that will provide families who have children in the ICU access to a support area including a lounge and play area,
- a rehabilitation gymnasium to provide early, integrated rehabilitation - to get ICU patients moving to assist in their recovery,
- a dedicated pod of beds which can be converted into a complete isolation pod in the event of an infectious threat, and
- dedicated critical care bays, which will enable high-end, complex interventions, reducing the need to transfer these patients to interstate facilities.

Emergency Department

The new Emergency Department (ED) will have 114 treatment spaces – 39 more than currently available at Canberra Hospital. In addition, the new ED will include:

- 4 behavioural assessment rooms,
- · bariatric and superbariatric treatment spaces.
- · a separate paediatrics stream treatment area, and
- other consultation and procedural areas, including specific waiting areas for treatment streams.

Furthermore, 10 Mental Health Short Stay Unit treatment spaces will be provided in SPIRE.

Coronary Care Unit

The Coronary Care Unit will include:

- 24 acute cardiac care beds, including bariatric and isolation beds,
- 4 interventional cardiac laboratories, including one hybrid cardiac laboratory and one electrophysiology laboratory, and
- · 27 interventional unit day beds.

Surgical and medical imaging facilities

SPIRE will increase the number of theatres at Canberra Hospital from 13 to 22. This will include state-of-the-art hybrid and interventional radiology theatres to allow the latest advances in medical technology to be used.

SPIRE will add to the medical imaging facilities available at Canberra Hospital, with:

- 2 new X-ray machines.
- · 3 CT Scanners, and
- an MRI machine.

SPIRE will also include more inpatient wards with 64 beds for overnight care and storage spaces for important medical equipment.

Teaching and learning

The Australian National University (ANU) have announced a new ANU building that will boost the teaching, training and research presence on the Hospital campus.

This is a significant investment in the SPIRE Centre that will co-locate medical research, the use of the latest technologies and clinical training and teaching.

It will ensure Canberra is best placed to attract the best and brightest students and clinicians nationally and internationally.

The Building Health Services Program


SPIRE is part of the Building Health Services Program (BHSP), which is ensuring the changing health care needs of our rapidly growing community will continue to be met into the future.







It is appropriate that we explore this option further as it may provide better clinical and wider strategic outcome. However, your observations re B4 are correct and it is unlikely that this building will come down in the near future. The future of B4 will be the subject of the master-planning process that will run parallel to SPIRE development over the next 9 months rather than a decision arrived at as part of SPIRE planning alone. One option may be that B4 is used as a decanting resource for several years post-SPIRE as other development on the campus is pursued and is then removed if necessary to realise the master-plan vision. However, it could equally be repurposed for a more permanent function. Also, even if the master-plan contemplates removal, this could easily change as time passes and new requirements emerge. Hospital master-plans tend to be a guide rather than a bible and will need to be updated from time to time.

I have added some responses (in red) to the matters below – but rest assured this exercise is appropriate design practice and no decisions will be made without careful consideration of the implications and relative merits and ratification through the governance arrangements – including clinicians. In addition, this site analysis work will not delay advancement to the more detailed design and technical work that we need to do for the ECI tender process.

Liz, Lloyd, Brad,

Following our conversation a few days ago, I had a few rookie questions / observations on the latest STH footprint.

I got the very strong sense that building 4 is going to be where it is for a long time yet – both because of it's remaining book value, but also because I'd imagine that demolishing a building so close to an operational SPIRE could produce its own problems. If it was necessary, this would not be an insurmountable problem. That being the case:

- Is it appropriate to base PoC design development on the possibility of B4 being removed? Or will it be more appropriate to design on the basis it will remain where it is? Whilst we are contemplating a future where B4 may be removed, this is not being considered as being a likelihood in the short, or even medium, term. Any repositioning of SPIRE has got to stack up as a better approach on the basis that B4 remains.
- If the latter does the current STH footprint represent the most appropriate design for the site? Or does assuming B4 stays where it is lead to a different design outcome? This is yet to be proved. Given the shifting scope, and the late introduction of the ANU project, there was little opportunity to refine site analysis and optimise building form in the run up to the business case. The primary focus was on proving that the building would fit and on generating costs plans. We have a call with STH tomorrow to brief them on feedback on the adjusted footprint and to direct them to flesh out this option and provide context on why it may be a better solution. As noted above, if we elect to go this route, it will have to work with B4 remaining in place.
- If B4 stays as is what provision is there for the future expansion of SPIRE? These issues will be explored in the work that STH will do next.
- What surrounding buildings, if any, does SPIRE need to physically link into? The clinical links are predominantly to the west over Hospital Road. These links are not materially different for the two orientations but again this needs to be demonstrated in the extra work that STH will do.



Purpose

To provide information on the relocation movements to accommodate the Child at Risk Health Unit decant from Canberra Hospital Building 5 to Building 3 Level1.

Background

The ACT government committed to an expansion of the Canberra Hospital (CH) in the 2016 election with the development of a Surgical Procedures, Interventional Radiology, and Emergency (SPIRE) Centre.

In December 2018, the ACT Government announced the location of the SPIRE building would be at the North end of the Eastern Corridor of the CH campus, where Buildings 5 and 24 are currently located.

To enable building to progress, the decanting and relocation of occupants and services from Building 5 and 24 will be followed by demolition of the existing buildings.

Services impacted by the decision to demolish these buildings includes the Child at Risk Health Unit.

A suitable location for the service has been identified in Building 3 Level 1. This area is currently occupied by forty-four staff from Infrastructure, Finance and Capital Works (IFCW), and Infrastructure and Health Support Services (IHSS).

Issues

The IHSS Executive Group Manager's office is located in building 3 level 1. His staff and services (including a conference room with seating capacity for fifteen) require accommodation within reasonable working distance from that executive office area.

A suitable area in Building 3 Level 1 has not been identified that can accommodate forty-four staff near the IHSS ED office. However the following two areas are capable of accommodating these numbers:

- The area currently occupied by the IHSS bed maintenance team (#14 on the attached plan). 86m2 x 4.4 = 19 workstations
- The old gym (#17 on the plan), currently occupied by the Digital Solutions COWS project. 130.9m2 x 4.4 = 30 workstations, plus a 42m2 conference room.

To decant the IFCW and IHSS staff in preparation for development of the CARHU relocation site, a series of decants and refurbishments will be required:

- 1. IHSS Bed Maintenance to Biomed Dirty Workshop (area #14)
- 2. Decanted area #14 refurbished for IHSS/IFCW office space
- 3. Digital solutions COWS project vacated from area #17
- 4. Decanted area #14 refurbished for IHSS/IFCW office space & conference room


