1. Introduction

The ACT Government committed to an expansion of the Canberra Hospital in the 2016 election with the development of a Surgical Procedures, Interventional Radiology, and Emergency (SPIRE) Centre. In September 2018, the Building Health Services Program Strategy Steering Committee agreed in-principle for the eastern corridor (North End) of the Canberra Hospital Campus, Garran be scoped as the future site of the SPIRE project.

This planning unit brief has been developed in response to the eastern corridor site proposal and will be used to inform early site planning, feasibility and proof of concept in the first instance. This planning unit brief has been developed with limited consultation and only approximates current space for an initial proof of concept and does not reflect what the service may need in the future.

2. Purpose

This Health Planning Unit (HPU) Brief defines the activities and functions undertaken in the Sexual Health Unit.

It is not the role of the HPU Brief to design the space, but rather to articulate the operational requirements, functionalities and relationships for which the architect can develop a suitable design response.

3. Description of the service

The role of the Canberra Sexual Health Centre (CSHC) is to provide broad sexual health care including, but not limited to screening, diagnosis and management of sexually transmitted infections and blood borne viruses, sexual function, contraception, menstrual problems, fertility concerns, menopause, genital dermatology, and transgender care.

4. Scope of service

The CSHC is located as a standalone unit in the north wing of Building 5, with access to Canberra Hospital support services.

The CSHC is a Role Delineation level 5 with a territory wide specialist support service role. The service is an outpatient based service with 'walk in' and booked appointments. There is prompt access to confidential services including health promotion and preventive health information, diagnostics and treatment at the point of care.

CSHC may be attended by any adult and adolescent person regardless of place of residence. Patients may self-refer or be referred from other health services, GPs or specialists.

Target population groups who may have particular needs include Aboriginal and Torres Strait Islander people, culturally and linguistically diverse people, young people (under 30 years), people living with HIV, people from high prevalence countries for Sexually Transmissible Infections (STI) and Human Immunodeficiency Virus (HIV) and their partners, travellers and mobile workers, sex workers, gay men and other men who have sex with men, people who inject drugs, people in custodial settings — or with a history of time in custody. Other clinic users may be those who need a service sensitive to their needs,

such as transgender people or those with a history of abuse. It is vital to maintain privacy and confidentiality for these patients.

Education and ongoing training of staff is supported by the CSHC to ensure a high quality service. Education occurs within the CSHC meeting rooms and clinic rooms, and is also provided off site.

Occasions of service at CSHC have been steadily increasing at approximately 8% per year over the past five years. Modelling of service demand and community trends in sexual health shows increases will continue in the near future.

5. Model of care summary

The focus of care provision within the Sexual Health Centre will be to provide confidential and high quality professional and non-judgemental care, with access to the latest information, advice and treatments.

Key features of the Model of Care (MoC) include:

- a population preventative health focus including preventive health and health promotion
- a focus on partnership with related disciplines, non-government service providers and other directorates
- targeted health priorities as articulated in the national action plans for STI and BBVs
- evidence based decision making
- quality population based health services, including offsite and outreach services to ensure easy access for vulnerable and at risk populations
- strong accountability and governance
- access to timely efficient and effective health care services
- pathology specimens collected by CSHC staff to maximise completion of requests
- option for results to be given face to face or by SMS
- timely access for pathology results
- Hospital avoidance strategies territory-wide include collaboration with GPs and Capital Health Network (CHN) for CSHC as a specialist service to support care in the community
- multidisciplinary teams, including allied health professionals will be accessible
- shared and/or collaborative care of patients with other specialties e.g. infectious diseases, respiratory, women's and children's, paediatric endocrinology, mental health, drug and alcohol unit, emergency department
- right skill mix in the right place at the right time
- maintaining privacy is paramount
- collaboration with ACT population health
- collaboration with external directorates (education and training, multicultural unit)
- specialist support to community based services providing sexual health care

6. Workforce

6.1. Canberra Sexual Health Centre workforce

Projected staff profiles have been developed to inform this stage of planning and will be subject to adjustment both in numbers and classification as better clarity is gained around MoC/service delivery models. This staffing profile is required to develop the schedule of accommodation only (e.g. offices, staff stations and receptions). Staff profiles are subject to review by Workforce Policy and Planning. Table 1 outlines the proposed sexual health workforce.

7. Policies impacting on the built environment

The Sexual Health service will adhere to the relevant design and space standards outlined in the Australasian Health Facility Guidelines (AusHFG) Part B – Health Facility Briefing and Planning.

Other policies impacting on the built environment include, but are not limited to:

- ACT Health (2012) Work Health & Safety Act and Regulations and Management Systems Policy.
- ACT Health (2012) Clinical Records Management Policy
- ACT Health Electronic Medicines Management Policy
- ACT Health Office and Workstation Accommodation guidelines
- Infection Prevention Control Policy
- Disability Discrimination Act, 1992
- Centralised Equipment Services(CES)
- National Health and Medical Research Council (2010). Australian Guidelines for the Prevention and Control of Infection in Health Care.

8. Operational description and associated design requirements

The Sexual Health Centre provides planned and unplanned diagnosis and treatment services to people of all ages who present with a wide range of sexual health conditions of varying urgency and complexity. The Sexual Health Centre is an outpatient and outreach based service, with inpatient consultation provided as requested. The CSHC unit operates drop in and booked clinics during business hours 5 days per week. Outreach and offsite care is provided to specific target groups. Specific clinics operate after hours at CSHC as per a yearly schedule.

Patients are either self-referred or referred by other health professionals, specialists or non-government organisations.

The service is available to all adults and young people in the ACT and surrounding areas including those without a Medicare card.

Sexual health services include:

- · STI and BBV screening, treatment and management
- pregnancy testing, counselling and referral
- emergency contraception
- immunisation
- HIV care including testing, diagnosis and management for newly diagnosed and long term clients, pre exposure prophylaxis and post exposure prophylaxis
- testing and treatment following occupational and non-occupational exposure
- medical management of gender transition
- genital dermatology
- sexual dysfunction and relationship concerns
- sexual assault care
- school based education programs
- management of occupational exposures for non-ACT Health staff.

The Sexual Health Centre consists of the following:

- entry area
- offices
- clinical rooms
- support areas
- · staff areas.

8.1. Entry area

The entry area consists of the reception entrance, the administration office, a waiting area and public amenities. Access points need to take into account provision for aged, bariatric, patients with a disability, carers and visitors.

8.1.1. Reception/clerical area.

Access to the CSHC is from a dedicated entrance. Patient entry is direct to the reception and administration area. Separate staff areas require proximity card access from the clinic areas and a separate external access door. Health information pamphlets and samples are available to clients.

8.1.2. Office/administration

Clerical services relating to patient presentation are located with reception and triage.

Clients present to a reception desk as the first point of contact. Administrative staff are located behind the reception desk in a shared office and are the focus of the initial presentation and associated clerical/administrative functions. Privacy and confidentiality are important at the reception desk. The administrative staff provide administrative tracking and recording of patient movement, patient data, reception duties, medical and nursing administrative support. Consideration in the proof of concept should be given to direct access to patient files from the administration area.

Patients are triaged as symptomatic or asymptomatic, directed to a nearby waiting area then seen by an appropriate clinician (nurse practitioner, doctor, nurse). Hand sanitizer is available in the entry areas.

8.1.3. Waiting area

During drop in clinics, wait times may be an hour or more. The waiting area has chairs and allows for privacy from the reception area and other traffic. Completion of initial screening questionnaires may occur in the waiting area. As per design requirements, consideration in the proof of concept should be given to pram parking, a play area and a sub waiting area for vulnerable clients.

8.1.4. Amenities

Shared public unisex toilets are located in the waiting area. As per design requirements, one toilet must be wheelchair accessible. Wi-Fi is available for clients.

8.2. Offices

CSHC includes a number of individual offices for medical and nursing staff allocated as per the ACT Health Accommodation Policy for all ACT Health Staff. These are located in a staff only area of the unit that requires proximity card access.

8.3. Clinical rooms

Clinic consult rooms in the CSHC contain an examination couch and light, and are multipurpose. Patients may have physical examination such as STI screening, specimen collection, blood collection, vaccinations and other treatment. Rooms and are also used for patient interview, counselling and phone consultations. All consult rooms require a handwashing basin. Shared toilet facilities are located nearby. One consult room has an ensuite as some patients may require showering after examination.

8.4. Support rooms

8.4.1. Specimen collection bay

This room has a phlebotomy chair and used for taking blood samples. The room requires close access to staff handwashing facilities.

8.4.2. Pathology Bay

A pathology bay located adjacent to the clinic consult rooms is used as a laboratory room for processing in-house samples, storage of samples awaiting transfer and performing microscopy.

8. Operational description and associated design requirements

The Sexual Health Centre provides planned and unplanned diagnosis and treatment services to people of all ages who present with a wide range of sexual health conditions of varying urgency and complexity. The Sexual Health Centre is an outpatient and outreach based service, with inpatient consultation provided as requested. The CSHC unit operates drop in and booked clinics during business hours 5 days per week. Outreach and offsite care is provided to specific target groups. Specific clinics operate after hours at CSHC as per a yearly schedule.

Patients are either self-referred or referred by other health professionals, specialists or non-government organisations.

The service is available to all adults and young people in the ACT and surrounding areas including those without a Medicare card.

Sexual health services include:

- STI and BBV screening, treatment and management
- pregnancy testing, counselling and referral
- emergency contraception
- immunisation
- HIV care including testing, diagnosis and management for newly diagnosed and long term clients, pre exposure prophylaxis and post exposure prophylaxis
- testing and treatment following occupational and non-occupational exposure
- medical management of gender transition
- genital dermatology
- sexual dysfunction and relationship concerns
- sexual assault care
- school based education programs
- management of occupational exposures for non-ACT Health staff.

The Sexual Health Centre consists of the following:

- entry area
- offices
- clinical rooms
- support areas
- · staff areas.

8.1. Entry area

The entry area consists of the reception entrance, the administration office, a waiting area and public amenities. Access points need to take into account provision for aged, bariatric, patients with a disability, carers and visitors.

8.1.1. Reception/clerical area.

Access to the CSHC is from a dedicated entrance. Patient entry is direct to the reception and administration area. Separate staff areas require proximity card access from the clinic areas and a separate external access door. Health information pamphlets and samples are available to clients.

8.1.2. Office/administration

Clients present to a reception desk as the first point of contact. Administrative staff are located behind the reception desk in a shared office and are the focus of the initial presentation and associated clerical/administrative functions. Privacy and confidentiality are important at the reception desk. The administrative staff provide administrative tracking and recording of patient movement, patient data, reception duties, medical and nursing administrative support. Consideration in the proof of concept should be given to direct access to patient files from the administration area.

Patients are triaged as symptomatic or asymptomatic, directed to a nearby waiting area then seen by an appropriate clinician (nurse practitioner, doctor, nurse). Hand sanitizer is available in the entry areas.

8.1.3. Waiting area

During drop in clinics, wait times may be an hour or more. The waiting area has chairs and allows for privacy from the reception area and other traffic. Completion of initial screening questionnaires may occur in the waiting area. As per design requirements, consideration in the proof of concept should be given to pram parking, a play area and a sub waiting area for vulnerable clients.

8.1.4. Amenities

Shared public unisex toilets are located in the waiting area. As per design requirements, one toilet must be wheelchair accessible. Wi-Fi is available for clients.

8.2. Offices

CSHC includes a number of individual offices for medical and nursing staff allocated as per the ACT Health Accommodation Policy for all ACT Health Staff. These are located in a staff only area of the unit that requires proximity card access.

8.3. Clinical rooms

Clinic consult rooms in the CSHC contain an examination couch and light, and are multipurpose. Patients may have physical examination such as STI screening, specimen collection, blood collection, vaccinations and other treatment. Rooms and are also used for patient interview, counselling and phone consultations. All consult rooms require a handwashing basin. Shared toilet facilities are located nearby. One consult room has an ensuite as some patients may require showering after examination.

8.4. Support rooms

8.4.1. Specimen collection bay

This room has a phlebotomy chair and used for taking blood samples. The room requires close access to staff handwashing facilities.

8.4.2. Pathology Bay

A pathology bay located adjacent to the clinic consult rooms is used as a laboratory room for processing in-house samples, storage of samples awaiting transfer and performing microscopy.

Alcohol based hand rub is available at the reception entrance and throughout the clinical areas for use by all staff and patients. Hand wash basins should be available throughout the unit as per design standards. Standard precautions will be used.

8.10. Information Communication Technology (ICT)

ICT services changes rapidly and the design process must acknowledge continuous development of policy and the impact it may have on implementation.

Specific ICT requirements include:

- Provision for computer assisted self-registration
- A patient record system that allows the right information to be available at the right time for the
 right person and supports clinical and administrative records. The unique patient registration and
 data management system used by Sexual Health staff is Specialised Health Information Program
 (SHIP). This program should support the transition from paper based to electronic records.
- Website accessible by the public for up to date service information and health information
- Wi-Fi
 - Provision for medically safe wireless networking throughout the clinical area.
 - Wi-Fi internet access will be provided throughout the unit (including lounge/wait areas) for use by staff and visitors
- Printer
 - Printers are required at the staff station and reception/administration.
- Hearing Loop
 - Hearing loop is to be available at reception/administration and one consult room
- Patient waiting room entertainment
 - TV in lounge/wait areas providing access to entertainment and health information.

8.11. Laboratory/biomedical

A small laboratory serves as a point of care testing station. Maintenance of point of care testing and examination equipment is required in the clinical areas.

Specific design requirements


9.1. Overarching design requirements

The design must:

- incorporate safe design principles
- allow for privacy and confidentiality including space to provide confidential phone consults or results
- be pleasant and friendly to help clients feel at ease, have relaxed comfortable furnishings
- natural light and ventilation where possible
- provide expansion space for future growth of the unit
- ensure there is sufficient storage for equipment
- floor and wall coverings are to support acoustic attenuation
