   However, it is important to note that there are often several complexities associated with the cause of death for an individual, including possible underlying health conditions.
- Due to the ACT's small sample size of deaths it is difficult to identify trends, however national data from the Commonwealth indicates that of deaths from COVID-19 nationwide, about 60 per cent were receiving palliative care.
- The key message from experts remains that vaccination significantly reduces the risk of serious illness for the majority of people, and we continue to encourage anyone who is eligible to get vaccinated.

- Seven of the people who died with COVID in 2022 were aged over 65, including four who were aged in their 80s and three in their 90s.
- Six had received a primary course (two doses) of COVID-19 vaccine, of which 1 had received a booster dose.

  Two were partially vaccinated, two were unvaccinated, and one person had an unknown vaccination status.
- ACT Health does not routinely collect comorbidity data for COVID-19 positive cases for reporting purposes.
- Older age is a risk factor for severe disease and death, as are several underlying comorbidities.
  - Commonwealth and NSW data reveals that approximately 80% of deaths due to COVID-19 are in those aged 70 years and over.

- There were 22 ICU patients from 01/01/2022 to 30/01/2022:
  - o 15 fully vaccinated, including 3 who had received a booster dose
  - 7 unvaccinated
- Due to the relatively small number of deaths and ICU admission in the ACT, it is not possible to
  identify trends by vaccination status. However, with such a high vaccination rate in the ACT and with
  the current level of community transmission of COVID-19, we expect to see some severe illness and
  deaths from COVID-19 among vaccinated individuals.
- This is reflected in NSW data: for cases between 26 November 2021 and 8 January 2022, although the number of hospitalisations, admissions to ICU and deaths was greater among those who had received two effective doses than those with no effective dose, the percentage of cases with these outcomes was still much higher among those with no effective dose. Among cases aged 12 and over with no effective dose in NSW, 8.9% of cases were hospitalised, 1.5% of cases were admitted to ICU, and 0.6% of cases died. In comparison, among cases who had received two effective doses, 1.0% of cases were hospitalised, 0.1% were admitted to ICU, and less than 0.1% died.
- The key message from experts and real world data remains that vaccination significantly reduces the
  risk of serious illness, and we continue to encourage anyone who is eligible to get vaccinated. The
  booster vaccination is particularly important in preventing serious health outcomes from the
  Omicron variant.

#### Deaths in 2022 from COVID-19

- From 1 Jan 2022, there have been 11 deaths from COVID-19 in the ACT six of these were in residents of aged care facilities.
- Seven of the people who died with COVID in 2022 were aged over 65, including four who were aged in their 80s and three in their 90s.
- Six had received a primary course (two doses) of COVID-19 vaccine, of which 1 had received a booster dose.

  Two were partially vaccinated, two were unvaccinated, and one person had an unknown vaccination status.
- ACT Health does not routinely collect comorbidity data for COVID-19 positive cases for reporting purposes.
- •Older age is a risk factor for severe disease and death, as are several underlying comorbidities.
  - Commonwealth and NSW data reveals that approximately 80% of deaths due to COVID-19 are in those aged 70 years and over.

## Hospital admissions in 2022 from COVID-19

- There were 22 ICU patients from 01/01/2022 to 30/01/2022:
  - o 15 fully vaccinated, including 3 who had received a booster dose
  - 7 unvaccinated
- Due to the relatively small number of deaths and ICU admission in the ACT, it is not possible to
  identify trends by vaccination status. However, with such a high vaccination rate in the ACT and with
  the current level of community transmission of COVID-19, we expect to see some severe illness and
  deaths from COVID-19 among vaccinated individuals.
- This is reflected in NSW data: for cases between 26 November 2021 and 8 January 2022, although the number of hospitalisations, admissions to ICU and deaths was greater among those who had received two effective doses than those with no effective dose, the percentage of cases with these outcomes was still much higher among those with no effective dose. Among cases aged 12 and over with no effective dose in NSW, 8.9% of cases were hospitalised, 1.5% of cases were admitted to ICU, and 0.6% of cases died. In comparison, among cases who had received two effective doses, 1.0% of cases were hospitalised, 0.1% were admitted to ICU, and less than 0.1% died.
- The key message from experts and real world data remains that vaccination significantly reduces the
  risk of serious illness, and we continue to encourage anyone who is eligible to get vaccinated. The
  booster vaccination is particularly important in preventing serious health outcomes from the
  Omicron variant.

We just conferred. Yes, Bec and I agree 17 deaths, 12 over 65 years.

Bec identified one more person in aged care so 10 in RACFs.

12 of the people who died with COVID in 2022 were aged over 65, including four who were aged in their 80s and six in their 90s.

(We had a rounding error of 0.1 years using date of death to calculate age c.f. date of notification. We will use date of notification from now on. This meant one person aged 89.9 went from 90s to 80s group.)

I have spoken with Bec about this. She agrees that we should be avoiding giving too much detail about deceased persons anyway to preserve confidentiality.

We suggest the following:

### Deaths in 2022 from COVID-19

- From 1 Jan 2022, there have been 17 deaths from COVID-19 in the ACT.
- 12 of the people who died with COVID in 2022 were aged over 65.

I would also suggest not stating 9 of these were reported among residents of aged care facilities since our records do not clearly or consistently identify RACFs. Dani and I agree that we were able to readily identify these 9, but we also agree that there may be more. Bec is of course aware and is already working on a solution going forward with respect to coding location.
