#### **DECISION ON YOUR ACCESS APPLICATION**

I refer to your application under section 30 of the *Freedom of Information Act 2016* (FOI Act), received by ACT Health Directorate (ACTHD) on **Monday 2 May 2022.** 

This application requested access to:

'All documents ACT Health produced or received in relation to Mrs Kim's Donuts at Kingston between November 2021 and April 2022, including reports, photographs and correspondence in connection to a reported food poisoning outbreak.

In addition, any documentation about the correspondence between and ACT Health when seeking information on Mrs Kim's Donuts.)'

I am an Information Officer appointed by the Director-General of ACT Health Directorate (ACTHD) under section 18 of the FOI Act to deal with access applications made under Part 5 of the Act. ACTHD was required to provide a decision on your access application by **Tuesday 31 May 2022.** 

I have identified 392 documents holding the information within scope of your access application. These are outlined in the schedule of documents included at <a href="Attachment A">Attachment A</a> to this decision letter.

#### **Decisions**

I have decided to:

- grant full access to 33 documents; and
- grant partial access to 359 documents.

My access decisions are detailed further in the following statement of reasons and the documents released to you are provided as <u>Attachment B</u> to this letter.

In reaching my access decision, I have taken the following into account:

- The FOI Act;
- The contents of the documents that fall within the scope of your request;
- The views of relevant third parties; and
- The Human Rights Act 2004.

#### **Full Access**

I have decided to grant full access to 33 documents at references 5-6, 10, 15-16, 21, 27-28, 52, 66, 78, 84, 93, 99, 103, 108, 114, 116, 164, 201, 236, 238, 289, 323, 339, 356, 359, 364, 369, 374, 384, 386, and 392.

#### **Partial Access**

I have decided to partially grant access to 392 documents.

# Public Interest Factors Favouring Disclosure

The following factors were considered relevant in favour of the disclosure of the documents:

- Schedule 2, 2.1(a)(i) promote open discussion of public affairs and enhance the government's accountability;
- Schedule 2, 2.1(a)(ii) contribute to positive and informed debate on important issues or matters of public interest; and
- Schedule 2.1(a)(xi) reveal environmental or health risks or measures relating to public health and safety.

## Public Interest Factors Favouring Non-Disclosure

The following factors were considered relevant in favour of the non-disclosure of the documents:

- Schedule 2, Schedule 2.2 (a)(ii) prejudice the protection of an individual's right to privacy or any other right under the *Human Rights Act 2004*;
- Schedule 2, Schedule 2.2 (a)(iii) prejudice security, law enforcement or public safety; and
- Schedule 2, Schedule 2.2 (a)(xi) prejudice trade secrets, business affairs or research of an agency or person.

The information contained in these documents are partially comprised of personal information such as surveys completed by non-ACT Government employees and their contact information. Redactions have also been made to ACT Government employees' signatures and mobile numbers. The redacted information would not provide any government information pertinent to your request therefore, I have decided this factor outweighs the public interest factors in the disclosure of this information. Documents at references 182 and 189 also contains information identified as Health Records under section 12 of the FOI Act outlines that this Act does not apply to information in a health record.

Documents at references 80, 298, 310 and 320 have redactions to information that could reasonably be expected to be detrimental to the security of the ACT Government. The redacted information contains internal links to Government files, and I have concluded that the release of this information would not advantage the public in disclosing this information.

Documents at references 49, 134, 155, 295, 299 and 390-391 have redactions to information descripting business affairs of non-ACT Government organisations. The release of this information could be detrimental to the businesses and not in the public interest.

Documents at references 360 and 365-366 have redactions made to information of both personal information and security.

Documents at references 51 and 389 has redactions to personal information, security and business affairs.

I have given significant consideration to the factors favouring disclosure and I believe the factors favouring non-disclosure outweighed these as the information requested could reasonably be expected to be detrimental to the identities of individuals, the security of the agency and the business affairs of other businesses. Therefore, I have determined the information identified is contrary to the public interest and would not advantage the public in disclosing this information.

## Charges

Processing charges are not applicable to this request.

#### **Disclosure Log**

Under section 28 of the FOI Act, ACTHD maintains an online record of access applications called a disclosure log. The scope of your access application, my decision and documents released to you will be published in the disclosure log not less than three days but not more than 10 days after the date of this decision. ## **Ombudsman review**
