#### **DECISION ON YOUR ACCESS APPLICATION**

I refer to your application under section 30 of the *Freedom of Information Act 2016* (FOI Act), received by ACT Health Directorate (ACTHD) on **Monday 12 December 2022**.

This application requested access to:

'Weekly raw statistics, for all of 2021-22, of the COVID-19 "vaccination" status of those in

- Hospital
- o ICU
- Died
  - Clearly state if the death was a) the primary cause of death or b) not the primary cause of death but the person had tested positive for COVID.'

I am an Information Officer appointed by the Director-General of ACT Health Directorate (ACTHD) under section 18 of the FOI Act to deal with access applications made under Part 5 of the Act. ACTHD was required to provide a decision on your access application by **Wednesday 18 January 2023**.

#### **Decisions**

ACTHD does not hold documents relevant to the scope of your application in accordance with section 35(1)(b).

### Charges

Processing charges are not applicable to this request.

## **Disclosure Log**
