DECISION ON YOUR ACCESS APPLICATION

I refer to your application under section 30 of the *Freedom of Information Act 2016* (FOI Act), received by the ACT Health Directorate (ACTHD) on **Friday 17 February 2023.**

ACT Health

The application requested access to:

Copies of any correspondence within the directorates and/or the minister's office regarding ACTHDFOI22-23.27.

I am an Information Officer appointed by the Director-General of ACTHD under section 18 of the FOI Act to deal with access applications made under Part 5 of the Act. ACTHD was required to provide a decision on your access application by **Monday 20 March 2023**.

I have identified nine documents holding the information within scope of your access application. These are outlined in the schedule of documents included at <u>Attachment A</u> to this decision letter.

Decisions on access

I have decided to:

- grant full access to eight documents; and
- grant partial access to one document.

My access decisions are detailed further in the following statement of reasons and the documents released to you are provided as <u>Attachment B</u> to this letter.

In reaching my access decision, I have taken the following into account:

- The FOI Act;
- The contents of the documents that fall within the scope of your request;
- The views of relevant third parties; and
- The Human Rights Act 2004.

Full Access

I have decided to grant full access to eight documents at references 1-6 and 8-9.

Partial Access

I have decided to grant partial access to one document at reference 7 as it contains information that I consider, on balance to be contrary to the public interest to disclose under the test set out in section 17 of the Act.

Public Interest Factors Favouring Disclosure

The following factors were considered relevant in favour of the disclosure of the documents:

- Schedule 2, 2.1(a)(i) promote open discussion of public affairs and enhance the government's accountability; and
- Schedule 2, 2.1(a)(ii) contribute to positive and informed debate on important issues or matters of public interest.

Public Interest Factors Favouring Non-Disclosure

The following factors were considered relevant in favour of the non-disclosure of the documents:

• Schedule 2, Schedule 2.2 (a)(ii) prejudice the protection of an individual's right to privacy or any other right under the *Human Rights Act 2004*.

On balance, the factors favouring disclosure did not outweigh the factor favouring non-disclosure as the redacted information contains the mobile phone number of an ACT Government employee. Therefore, I determined the information identified is contrary to the public interest and I have decided not to disclose this information.

Charges

Processing charges are not applicable to this request.

Disclosure Log

Under section 28 of the FOI Act, ACTHD maintains an online record of access applications called a disclosure log. The scope of your access application, my decision and documents released to you will be published in the disclosure log not less than three days but not more than 10 days after the date of this decision. Your personal contact details will not be published.

Ombudsman review

My decision on your access request is a reviewable decision as identified in Schedule 3 of the FOI Act. Hi Rebecca

I just wanted to provide you with an update on the below matter for awareness.

Following the intention to refuse the FOI request from Ms Lee, her office has been unable to negotiate a rescope of the request. Upon receiving the intention to refuse letter Ms Lee's staff requested that the request be broken down into smaller requests and provided by either brief type or area of business. In discussion with the FOI Team this was considered to increase the work required to facilitate and provide the requested documents through a greater administrative and coordination burden. Ms Lee's office was provided an extension on the timeframe for rescoping the request but have chosen not to do so.

Noting that the request has not been rescoped within either the initial timeframe nor the extended timeframe provided, the FOI Team has now drafted a letter for me to sign and send to Ms Lee, see attached. I am planning to sign and send the letter before the end of the week, but wanted to provide to you for awareness and to close the loop prior to this being progressed.

Additionally, Ms Lee and her office have initiated a further new request, seeking the first ten briefs included in the refused request. I have some concerns that Ms Lee's office intend to request the briefs in smaller packages over time to try and seek the same information that has been refused due to the unreasonable diversion of resources to provide. I am working closely with the FOI Team and have raised my concerns with them and we will continue to monitor this situation, noting that when numerous, similar requests are received from the same party they can, under the FOI Act, be rolled into a single request and potentially still be refused on the grounds of being an unreasonable diversion of resources.

We have recently released a list of 130+ titles of briefs and are still awaiting a request to come through for the chosen briefs from this list in addition to other FOI requests currently underway.

As previously discussed with Vivien as your Head of Office, the volume, complexity and frequency of the FOI requests being received, in particular from this applicant are requiring substantial diversion of resources from within the MAGS and FOI teams to be able to facilitate, hence I wanted to provide you with this information for ongoing awareness of the situation.

Dear Rebecca

As you are aware the Directorate is receiving a high volume of FOI requests for briefings progressed to Ministers. After the recent release of a list of briefs progressed by ACTHD to Minister's, Ms Lee's Office she has now requested the release of 47 briefs included on the list. I am inclined to make a determination to refuse / seek rescope of the request to a more reasonable number due to this being an unreasonable diversion of resources.

The review and coordination of this type of FOI pack involves significant work and resourcing from both the MAGS and FOI Teams to process. There is consultation more broadly across line areas in the Directorate with reviews occurring on specific briefs and content by subject matter experts to ensure that information is appropriate for release under the FOI ACT.

Historically, the requests received have not exceeded 32 briefs plus assorted QTBs and other packs have ranged from 14 - 29 briefs. All prior requests have been completed, however the work required on these packs with lower numbers have still been challenging to complete in the timeframes set under the FOI Act.

When the application was initially received I requested advice from the FOI Team on any awareness on thresholds set in other Directorates who are receiving similar requests. I understand that CMTEDD have issued letters of refusal and these are currently undergoing ombudsman reviews with no result available to set a precedence at this time. Other Directorates have been understood to progress packs where approximately 30 briefs have been requested.

I wanted to raise with you as the Directorate's Principal Officer prior to issuing an intent to refuse letter. Should you request that the application be processed, in the format received (all 47 briefs), we will need to approach Ms Lee's Office to seek an extension for processing the request as it is just not feasible to action the request noting the volume in the routine timeframes.
