Outline of the project (250 words max)

Patient partnerships are a pillar of person centred care; that is, care that focuses on the relationship between a patient and a clinician. The Australian Commission on Safety and Quality in Health Care Standards includes 'Partnering with Consumers' as Standard 2. While clinicians accept and value this principal, there are particular challenges for patients who require additional support to communicate effectively with their care team. These include patients from a culturally and linguistically diverse background (including Aboriginal and Torres Strait Islanders), those with a cognitive impairment, those with a disability (including communication disabilities such as aphasia), neuro-diverse people and those who are hearing or vision impaired.

Evidence in the literature demonstrates that suboptimal communication seriously compromises patient quality of care and health outcomes. Furthermore, anecdotal evidence suggests existing resources such as interpreters, communication boards and personal amplifiers are not being used.

The aim of this project is to understand current practices used by clinicians to support patients with increased communication challenges and identify barriers to these practices being utilised more broadly. When this is understood, recommendations can be made to optimise the safe and quality care of vulnerable patients in our care.

Proposed research methods

Participants will include medical, nursing and allied health professionals working in the General Medical and Surgical wards at the North Canberra Hospital.

Methods will include:

- Literature review
- a retrospective electronic medical record audit of interpreter and Aboriginal Liaison
 Officer use
- An analysis of interpreter booking data over the previous 6 months
- A point in time review of inpatient documented communication needs compared to utilisation of resources to support communication at the bedside.
- Focus groups involving medical, nursing and allied health staff

Preferred study discipline being undertaken by the student

Medical, Speech Pathology, Occupational Therapy, Social Work or Psychology

Benefits to the student and to the department

The student will have the opportunity to development a nuanced understanding of the needs of patients who require support to communicate effectively with their care team and to increase their capacity to deliver effective patient centred care. The project will also provide the opportunity to increase understanding of various Allied Health disciplines and the ability to work inter-professionally. There may be an opportunity to share information as a poster or conference presentation or to submit for publication.

The project will assist the Department to understand the needs of patients who require support to communicate effectively with their care team and to increase their capacity to deliver safe and effective patient centred care. Recommendations will also be used to inform decisions around the purchase of equipment, ongoing education and training.

In addition, the Director of the Social Work Department is a member of the Standard 2 Partnering with Consumers Committee for NCH and the project will provide important information to guide the work of the committee across the wider hospital.

The project employs a continuous improvement approach to health care delivery. In addition it specifically aims to build effective partnerships between clinicians and consumers who face additional communication challenges.

To ensure diversity to meet the future healthcare needs of the ACT there must be an understanding of the difference between the principles of equity and equality. Without this there cannot be a respect for and commitment to meeting the needs of patients in our care, or indeed our colleagues, who require additional support to communicate effectively. The project shines a light on the experience of this group of people and will provide a sound evidence base to inform decisions about future resourcing, education and training needs.

Australian research by White et al *International Journal for Equity in Health* (2018) 17:151 concluded that there was a need for "systemic and transformative change" in relation to interpreter use. This project aims to build on this information and expand the cohort beyond the use of interpreters and to make clear recommendations for change given the risk to the quality of care and health outcomes for a vulnerable cohort of patients.
